SENATE BILL NO. 2437

- AN ACT TO AMEND SECTION 9-9-11, MISSISSIPPI CODE OF 1972, TO REVISE THE SALARY OF THE COUNTY COURT JUDGE OF DESOTO COUNTY; AND FOR RELATED PURPOSES.
- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 5 **SECTION 1.** Section 9-9-11, Mississippi Code of 1972, is
- 6 amended as follows:
- 7 9-9-11. (1) Except as otherwise provided in subsections (2)
- 8 and (3), the county court judge shall receive an annual salary
- 9 payable monthly out of the county treasury in an amount not to
- 10 exceed One Thousand Dollars (\$1,000.00) less than the salary which
- 11 is now or shall hereafter be provided for circuit and chancery
- 12 judges of this state, in the discretion of the board of
- 13 supervisors of said county; provided, however, that the salary of
- 14 such judge shall not be reduced during his term of office.
- 15 Provided further, that the office of county court judge in any
- 16 county receiving an annual salary of Thirty-six Thousand Dollars
- 17 (\$36,000.00) or more shall be a full-time position, and the holder
- 18 thereof shall not otherwise engage in the practice of law.
- 19 (2) In the event of the establishment of a county court by
- 20 agreement between two (2) or more counties as provided in Section
- 21 9-9-3, the county judge of the court so established shall be paid
- 22 a salary equal to one and one-half (1-1/2) times that salary that
- 23 he would be paid if he were the judge of the smallest of such two
- 24 (2) or more counties, such salary to be paid in monthly
- 25 installments as provided by law; provided that such salary shall
- 26 not exceed One Thousand Dollars (\$1,000.00) less than the salary
- 27 of the circuit and chancery judges of this state.

- 28 (3) The county court judge shall receive an annual salary 29 payable monthly out of the county treasury as follows:
- 30 (a) In any county having a population of seventy
- 31 thousand (70,000) or more according to the 1980 federal census,
- 32 the county judge shall receive an annual salary of One Thousand
- 33 Dollars (\$1,000.00) less than that paid to a circuit court judge.
- 34 The office of county judge shall be a full-time position, and the
- 35 holder thereof shall not otherwise engage in the practice of law.
- 36 (b) In any county having a population of sixty thousand
- 37 (60,000) or more but less than seventy thousand (70,000) according
- 38 to the 1980 federal census, the county judge shall receive an
- 39 annual salary of Forty Thousand Dollars (\$40,000.00). The office
- 40 of county judge shall be a full-time position, and the holder
- 41 thereof shall not otherwise engage in the practice of law. The
- 42 county judge shall not be eligible for any additional salary
- 43 except as may be authorized in subsection (4).
- (c) In any county having a population of twenty-seven
- 45 thousand (27,000) or more but less than sixty thousand (60,000)
- 46 according to the 1980 federal census, the county judge shall
- 47 receive an annual salary of not less than Twelve Thousand Dollars
- 48 (\$12,000.00) but not more than Forty Thousand Dollars
- 49 (\$40,000.00), in the discretion of the board of supervisors of
- 50 said county. The county judge shall not be eligible for any
- 51 additional salary except as may be authorized in subsection (4).
- 52 In the event that the board of supervisors of said county elects
- 53 to pay such county judge an annual salary of Thirty Thousand
- 54 Dollars (\$30,000.00) or more, the office of county judge shall be
- 55 a full-time position, and the holder thereof shall not otherwise
- 56 engage in the practice of law.
- 57 (d) In any county having a population of less than
- 58 twenty-seven thousand (27,000) according to the 1980 federal
- 59 census, the county judge shall receive an annual salary of not
- 60 less than Four Thousand Two Hundred Dollars (\$4,200.00) and not

- more than Eight Thousand Five Hundred Dollars (\$8,500.00), in the 61
- discretion of the board of supervisors of said county. The county 62
- judge shall not be eligible for any additional salary except as 63
- may be authorized in subsection (4). 64
- 65 The county judge of any county described in this
- 66 subsection shall be paid the compensation, and he shall be subject
- to any restrictions, set forth in the following paragraphs: 67
- The county judge of any such Class 1 county with 68 (a)
- population according to the latest federal decennial census of 69
- forty-five thousand (45,000) or more and lying wholly within a 70
- 71 levee district and having two (2) judicial districts shall, in the
- discretion of the board of supervisors of such county, receive an 72
- annual salary not exceeding Forty Thousand Dollars (\$40,000.00), 73
- or a sum which is One Thousand Dollars (\$1,000.00) less than the 74
- 75 salary which is now or shall hereafter be provided for circuit and
- 76 chancery judges of the state, whichever is greater.
- 77 The county judge of any Class 1 county having an (b)
- area in excess of nine hundred twenty-five (925) square miles 78
- shall receive an annual salary of not less than Thirty Thousand 79
- 80 Dollars (\$30,000.00) but, in the discretion of the board of
- supervisors of such county, such salary may be not more than Five 81
- Hundred Dollars (\$500.00) less than the annual salary of a circuit 82
- judge, payable monthly out of the county treasury, and the county 83
- judge shall not practice law. 84
- 85 The office of county judge in any such Class 1
- county with a population according to the 1970 federal decennial 86
- census of greater than thirty-nine thousand (39,000), and where 87
- U.S. Highway 61 and Mississippi Highway 6 intersect, shall receive 88
- an annual salary to be paid in monthly installments of not less 89
- than an amount equal to ninety percent (90%) of the annual salary 90
- which is now or shall hereafter be provided for circuit and 91
- 92 chancery judges of the state, as follows: The salary of the
- county judge shall be increased by ten percent (10%) annually 93

- above the base salary of the preceding year until such time as the judge's salary is equal to the amount that is provided by this subsection. The office of county judge shall be a full-time
- 97 position and the holder thereof shall not otherwise engage in the
- 98 practice of law.
- 99 (d) In any Class 1 county bordering on the Mississippi
- 100 River and which has situated therein a national military park and
- 101 national military cemetery, the office of county judge shall be a
- 102 full-time position and the holder thereof shall not otherwise
- 103 engage in the practice of law. The salary for the county judge in
- 104 said county shall be fixed at a sum which is One Thousand Dollars
- 105 (\$1,000.00) less than the salary which is now or shall hereafter
- 106 be provided for circuit and chancery judges of this state.
- 107 (e) The county judge in any county having a population
- 108 of at least forty-two thousand one hundred eleven (42,111),
- 109 according to the 1970 census, and where U.S. Highway 49E and U.S.
- 110 Highway 82 intersect, shall receive an annual salary to be paid in
- 111 monthly installments of not less than Thirty Thousand Dollars
- 112 (\$30,000.00) but not more than Two Thousand Five Hundred Dollars
- 113 (\$2,500.00) less than the annual salary of the circuit judge, in
- 114 the discretion of the board of supervisors of that county.
- (f) The county judge in any Class 1 county bordering on
- 116 the Mississippi River and having an area of less than four hundred
- 117 fifty (450) square miles wherein U.S. Highways 84 and 61 intersect
- 118 shall receive an annual salary of Four Thousand Dollars
- 119 (\$4,000.00) less than the annual salary of a circuit judge, and
- 120 such county judge shall not practice law in any manner. The
- 121 county judge in such county shall not be eligible to receive any
- 122 additional salary authorized by this section or from any other
- 123 source other than that set out and authorized by this paragraph.
- 124 (g) The county judge of any Class 1 county bordering on
- 125 the Mississippi River on the west and the State of Tennessee on
- 126 the north, and traversed north to south by Interstate Highway 55,

- 127 shall receive an annual salary of One Thousand Dollars (\$1,000.00)
- 128 less than that paid to a circuit court judge. The office of
- 129 county judge shall be a full-time position, and the holder thereof
- 130 shall not otherwise engage in the practice of law.
- (h) The county judge of any Class 1 county with a
- 132 population of greater than sixty-nine thousand (69,000) according
- 133 to the 1980 federal decennial census, and wherein U.S. Highway 80
- 134 and Mississippi Highway 43 intersect, shall receive an annual
- 135 salary in an amount not greater than the sum of Five Hundred
- 136 Dollars (\$500.00) less than the salary which is now or shall
- 137 hereafter be provided for circuit and chancery judges of this
- 138 state, in the discretion of the board of supervisors of $\underline{\text{that}}$
- 139 county.
- 140 (i) The county judge of any county having a population
- 141 in excess of sixty-six thousand (66,000) according to the 1980
- 142 federal decennial census, wherein is located a state-supported
- 143 university and in which U.S. Highways 49 and 11 intersect, shall
- 144 receive an annual salary of One Thousand Dollars (\$1,000.00) less
- 145 than that paid to a circuit court judge. The office of such
- 146 county judge shall be a full-time position, and the holder thereof
- 147 shall not otherwise engage in the practice of law.
- 148 (j) The county judge of any county having two (2)
- 149 judicial districts, having a population in excess of sixty-one
- 150 thousand nine hundred (61,900) according to the 1980 federal
- 151 decennial census, in which U.S. Interstate Highway 59 intersects
- 152 with U.S. Highway 84, shall receive an annual salary of One
- 153 Thousand Dollars (\$1,000.00) less than the salary which is now or
- 154 hereafter authorized to be paid circuit and chancery court judges
- 155 of this state. The office of such county judge shall be a
- 156 full-time position, and the holder thereof shall not otherwise
- 157 engage in the practice of law.
- 158 (k) The office of county judge of any Class I county
- 159 wherein U.S. Highway 51 and U.S. Highway 98 intersect shall be a

full-time position and the holder thereof shall not otherwise
engage in the practice of law. The annual salary for the office
of county judge in said county may be fixed, in the discretion of
the board of supervisors of said county, at a sum not to exceed
Two Thousand Dollars (\$2,000.00) less than the salary which is now
or shall hereafter be provided for circuit and chancery judges of
this state.

- The county judge of any county having a population 167 (1)of more than forty-one thousand six hundred (41,600) but less than 168 forty-one thousand six hundred fifty (41,650) according to the 169 170 1980 federal census, and wherein U.S. Highway 49 intersects with Mississippi Highway 22, shall receive an annual salary in an 171 172 amount established by the board of supervisors, but in no event to exceed the salary provided now or hereafter for circuit and 173 chancery judges of this state. 174
- The county judge of any county having a population 175 of more than fifty-seven thousand (57,000) but less than 176 fifty-seven thousand one hundred (57,100) according to the 1980 177 federal census, wherein U.S. Highway 45 intersects with 178 179 Mississippi Highway 6, shall receive an annual salary in an amount established by the board of supervisors, but in no event to exceed 180 181 the salary provided now or hereafter for circuit and chancery judges of this state. 182
- The county judge of any county having a population 183 (n) 184 of more than fifty-seven thousand three hundred (57,300) according to the 1980 federal decennial census, wherein is located a 185 186 state-supported university and wherein United States Highways 82 187 and 45 intersect, shall receive an annual salary in an amount established by the board of supervisors, but in no event to exceed 188 the salary provided now or hereafter for circuit and chancery 189 190 judges of this state.
- 191 (5) The salary of a county court judge or justice court

 192 judge shall not be reduced during his term of office as a result

- of a population decrease based upon the 1990 federal decennial census.
- 195 (6) The salary of a sheriff shall not be reduced during his 196 term of office as a result of a population decrease based upon the 197 1990 federal decennial census.
- From and after October 1, 1993, or the effective date of 198 this act [Laws, 1993, Chapter 550], whichever is later, in 199 addition to the salaries set forth in this section, the board of 200 supervisors of any county, in its discretion, may pay any county 201 court judge whose salary is not established herein in relation to 202 203 the salary paid to chancery and circuit court judges, an 204 additional amount not to exceed ten percent (10%) of the maximum 205 allowable salary for that judge.
- section 2. The Attorney General of the State of Mississippi shall submit this act, immediately upon approval by the Governor, or upon approval by the Legislature subsequent to a veto, to the Attorney General of the United States or to the United States

 District Court for the District of Columbia in accordance with the provisions of the Voting Rights Act of 1965, as amended and extended.
- SECTION 3. This act shall take effect and be in force from and after the date it is effectuated under Section 5 of the Voting Rights Act of 1965, as amended and extended.
