COMMITTEE SUBSTITUTE FOR SENATE BILL NO. 2783

- AN ACT TO AMEND SECTION 59-21-3, MISSISSIPPI CODE OF 1972, TO CLARIFY THE DEFINITION OF LIVERY BOAT; AND FOR RELATED PURPOSES.
- 3 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 4 SECTION 1. Section 59-21-3, Mississippi Code of 1972, is
- 5 amended as follows:
- 6 59-21-3. As used in this chapter, unless the context clearly
- 7 requires a different meaning:
- 8 (a) "Commission" means the Mississippi Commission on
- 9 Wildlife, Fisheries and Parks.
- 10 (b) "Length" means the length of the vessel measured
- 11 from end to end over the deck excluding sheer.
- 12 (c) "Livery boat" means any boat or canoe for rent or
- 13 hire.
- 14 (d) "Machinery" means inboard and outboard engines and
- 15 all other types of motors or mechanical devices.
- 16 (e) "Motorboat" means any undocumented vessel propelled
- 17 by machinery, whether or not such machinery is the principal
- 18 source of propulsion. The term motorboat includes personal
- 19 watercraft.
- 20 (f) "Operate" means to navigate or otherwise use a
- 21 motorboat or vessel.
- 22 (g) "Operator" means the person who operates or who has
- 23 charge of the navigation or use of a motorboat or a vessel.
- (h) "Owner" means the person who claims lawful
- 25 possession of a vessel by virtue of legal title or equitable
- 26 interest therein which entitles him to such possession.

- 27 (i) "Person" means an individual, partnership, firm,
- 28 corporation, association or other entity.
- 29 (j) "Ships' lifeboats" means lifeboats used solely for
- 30 lifesaving purposes and does not include dinghies, tenders,
- 31 speedboats, or other type of craft carried aboard a vessel and
- 32 used for other than lifesaving purposes.
- 33 (k) "Undocumented vessel" means any vessel which is not
- 34 required to have, and does not have, a valid marine document
- 35 issued by the Bureau of Customs.
- 36 (1) "Vessel" means every description of watercraft,
- 37 other than seaplane on the water, used or capable of being used as
- 38 a means of transportation on water.
- 39 (m) "Waters of this state" means any waters within the
- 40 territorial limits of this state, and the marginal sea adjacent to
- 41 this state and the high seas when navigated as a part of a journey
- 42 or ride to or from the shore of the state; however, "waters of
- 43 this state" does not mean any private pond or lake which is not
- 44 used for boat rentals or the charging of fees for fishing therein.
- 45 **SECTION 2.** This act shall take effect and be in force from
- 46 and after July 1, 2003.
