SENATE BILL NO. 2894

AN ACT TO AMEND SECTION 63-1-35, MISSISSIPPI CODE OF 1972, TO PROVIDE THAT THE REQUIREMENT THAT AN APPLICANT FOR A DRIVER'S LICENSE PRESENT HIS SOCIAL SECURITY NUMBER TO THE DEPARTMENT OF PUBLIC SAFETY SHALL NOT BE APPLICABLE TO A PERSON WHO FILES AN 3 AFFIDAVIT WITH THE DEPARTMENT AFFIRMING THAT HE HAS NEVER BEEN ISSUED A SOCIAL SECURITY NUMBER; TO AMEND SECTION 63-1-19, 6 MISSISSIPPI CODE OF 1972, TO PRESCRIBE THE TYPES OF DOCUMENTS THAT 7 AN APPLICANT FOR A MISSISSIPPI DRIVER'S LICENSE MAY PROVIDE TO THE DRIVER'S LICENSE EXAMINER IN ORDER TO SHOW PROOF OF RESIDENCE; AND 8 9 FOR RELATED PURPOSES. 10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 11 SECTION 1. Section 63-1-35, Mississippi Code of 1972, is

- amended as follows: 13
- 63-1-35. (1) The Commissioner of Public Safety shall 14
- prescribe the form of licenses issued pursuant to this article 15
- which shall, among other features, include a driver's license 16
- number assigned by the Department of Public Safety which, at the 17
- option of the licensee, may or may not be the social security 18
- number of the licensee. A licensee who chooses not to use his 19
- social security number as his driver's license number, except as 20
- otherwise provided under subsection (2) of this section, shall 21
- list his social security number with the department which shall 22
- cross reference the social security number with the driver's 23
- license number for purposes of identification. Additionally, each 24
- license shall bear a full face color photograph of the licensee in 25
- such form that the license and the photograph cannot be separated. 26
- Such photograph shall be taken so that one (1) exposure will 27
- photograph the applicant and the application simultaneously on the 28
- 29 same film. The department shall use a process in the issuance of
- a license with a color photograph which shall prevent as nearly as 30
- possible any alteration, counterfeiting, duplication, 31

- 32 reproduction, forging or modification of such license or the
- 33 superimposition of a photograph without ready detection. Such
- 34 photograph shall be replaced by the department at the time of
- 35 renewal. Driver licenses, including photographs appearing
- 36 thereon, may be renewed by electronic means according to rules and
- 37 regulations promulgated by the commissioner. The Department of
- 38 Public Safety may accept bank credit cards and debit cards in
- 39 payment of fees for driver license renewals that are processed by
- 40 electronic means and, if authorized by general law, may charge an
- 41 additional fee for the use of such cards.
- 42 (2) An applicant who does not have, or who states that he
- 43 has never been issued, a social security number as required under
- 44 subsection (1) of this section, shall complete an affidavit, under
- 45 penalty of perjury, affirming that he has never been issued a
- 46 <u>social security number</u>.
- 47 **SECTION 2.** Section 63-1-19, Mississippi Code of 1972, is
- 48 amended as follows:
- 49 63-1-19. (1) Every applicant for a license issued pursuant
- 50 to this article shall file an application for such license, on a
- 51 form provided by the Department of Public Safety, with the
- 52 commissioner or an official license examiner of the department.
- 53 All persons not holding valid, unexpired licenses issued in this
- 54 state shall be required to secure an original license, except
- 55 those specifically exempted from licensing under Section 63-1-7.
- 56 The application shall state the name, date of birth, sex, race,
- 57 color of eyes, color of hair, weight, height and residence
- 58 address, and whether or not the applicant's privilege to drive has
- 59 been suspended or revoked at any time, and, if so, when, by whom,
- 60 and for what cause, and whether any previous application by him
- 61 has been denied, and whether he has any physical defects which
- 62 would interfere with his operating a motor vehicle safely upon the
- 63 highways.



64	(2) Every applicant for an original license shall show proof
65	of $\underline{\text{residence}}$ in this state. * * * An applicant for an original
66	license may show proof of residence in this state by presenting to
67	the license examiner at least two (2) of the following documents:
68	(a) A utility bill, including telephone service,
69	showing a valid residential address;
70	(b) A bank statement showing a valid Mississippi
71	address;
72	(c) An acceptable employer verification, such as an
73	employment identification card, a letter from the employer on its
74	official letterhead or a payroll check or payroll check stub;
75	(d) An automobile, life or health insurance policy
76	showing a valid Mississippi address;
77	(e) A driver's license issued by the State of
78	Mississippi to a parent, legal guardian or spouse;
79	(f) A Mississippi motor vehicle registration showing a
80	valid Mississippi address;
81	(g) An Internal Revenue Service Tax Reporting W-2 Form;
82	(h) A receipt for personal or real estate taxes paid
83	within the last year showing a valid Mississippi address;
84	(i) A copy of a residential lease showing a valid
85	Mississippi address; or
86	(j) If the applicant is a student enrolled in a public
87	or private school in Mississippi, a photo student identification
88	and acceptable documentation that the student resides on campus.
89	(3) If an applicant is unable to provide at least two (2) of
90	the documents described in subsection (2) of this section, he may
91	provide one of the documents described in subsection (2) of this
92	section and one of the following documents:
93	(a) The Individual Taxpayer Identification Number
94	(ITIN) issued by the Internal Revenue Service;
95	(b) Form I-94 issued to the applicant by the United

States Immigration and Naturalization Service;

97	(c) An Employment Authorization Card (EAD) issued to
98	the applicant by the United States Immigration and Naturalization
99	Service;
100	(d) A Permanent Residence Card issued to the applicant
101	by the United States Immigration and Naturalization Service; or
102	(e) A stamp in a foreign passport issued by the United
103	States Immigration and Naturalization Service showing evidence of
104	lawful admission for permanent residence.
105	(4) The documents described in subsection (1) and (2) of
106	this section must include the applicant's name or the name of the
107	applicant's spouse, if the applicant has a spouse, or if the
108	applicant is a minor, the name of a parent or legal guardian.
109	These documents must also show the valid residence address of the
110	applicant being used on the application for the Mississippi
111	driver's license.
112	Each application or filing made under this section, except as
113	otherwise provided under Section 63-1-35(2), shall include the
114	social security number(s) of the applicant in accordance with
115	Section 93-11-64, Mississippi Code of 1972.
116	SECTION 3. This act shall take effect and be in force from
117	and after July 1, 2002.
