AN ACT MAKING AN ADDITIONAL APPROPRIATION FROM THE WORKING 1 CASH-STABILIZATION RESERVE FUND TO THE STATE DEPARTMENT OF 2 EDUCATION FOR THE PURPOSE OF FUNDING THE MINIMUM EDUCATION 3 4 PROGRAM, THE MISSISSIPPI ADEQUATE EDUCATION PROGRAM AND THE CHICKASAW SCHOOL FUND FOR THE FISCAL YEAR 2002. 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 6 7 **SECTION 1.** In addition to all other sums previously appropriated, the following sum, or so much of it as may be 8 necessary, is appropriated out of any money in the Working 9 Cash-Stabilization Reserve Fund created in Section 27-103-203, 10 Mississippi Code of 1972, that is not otherwise appropriated, to 11 the State Department of Education for the purpose of funding the 12 Minimum Education Program for the fiscal year ending 13 14 June 30, 2002..... \$45,550,984.00. SECTION 2. This additional appropriation is made for the 15 purpose of restoring cuts made by the Governor on February 11, 16 2002, to the Minimum Education Program. 17 SECTION 3. In addition to all other sums previously 18 appropriated, the following sum, or so much of it as may be 19 necessary, is appropriated out of any money in the Working 20 21 Cash-Stabilization Reserve Fund created in Section 27-103-203, 22 Mississippi Code of 1972, that is not otherwise appropriated, to 23 the State Department of Education for the purpose of funding the Mississippi Adequate Education Program for the fiscal year ending 24 June 30, 2002..... \$ 3,505,554.00. 25 SECTION 4. This additional appropriation is made for the 26 27 purpose of restoring cuts made by the Governor on February 11, 28 2002, to the Mississippi Adequate Education Program.

In addition to all other sums previously 29 SECTION 5. appropriated, the following sum, or so much of it as may be 30 necessary, is appropriated out of any money in the Working 31 32 Cash-Stabilization Reserve Fund created in Section 27-103-203, 33 Mississippi Code of 1972, that is not otherwise appropriated, to 34 the State Department of Education for the purpose of paying annual compensation to the Chickasaw Cession counties for sixteenth 35 section lands which they lost through sale by the state, as 36 provided in Sections 29-3-137 through 29-3-141, Mississippi Code 37 of 1972, for the fiscal year ending..... 38 39 June 30, 2002.....\$ 518,722.00. SECTION 6. This additional appropriation is made for the 40 41 purpose of restoring cuts made by the Governor on February 11, 2002, to the Chickasaw School Fund. 42 SECTION 7. In addition to all other sums previously 43 appropriated, the following sum, or so much of it as may be 44 necessary, is appropriated out of any money in the Working 45 46 Cash-Stabilization Reserve Fund created in Section 27-103-203, Mississippi Code of 1972, that is not otherwise appropriated, to 47 48 the State Department of Education for the purpose of funding the Uniform Millage Assistance Grants Program for the fiscal year 49 50 ending June 30, 2002..... \$ 1,070,001.00. This additional appropriation is made for the SECTION 8. 51 purpose of restoring cuts made by the Governor on February 11, 52 53 2002, to the Uniform Millage Assistance Grants Program. SECTION 9. The money appropriated by this act shall be paid 54 55 by the State Treasurer out of any money in the Working Cash-Stabilization Reserve Fund that is not otherwise 56 57 appropriated, upon warrants issued by the State Fiscal Officer; 58 and the State Fiscal Officer shall issue his warrants upon requisitions signed by the proper person, officer or officers in 59 60 the manner provided by law.
