## SENATE CONCURRENT RESOLUTION NO. 501

1	A CONCURRENT RESOLUTION PROPOSING TO AMEND THE MISSISSIPPI
2	CONSTITUTION OF 1890 BY AMENDING SECTION 140 AND REPEALING
3	SECTIONS 141 AND 142 TO PROVIDE THAT THE PERSON RECEIVING THE
4	MAJORITY OF VOTES FOR THE OFFICE OF GOVERNOR AT THE GENERAL
5	ELECTION SHALL BE DECLARED ELECTED; IF NO PERSON RECEIVES A
6	MAJORITY OF THE VOTES, TO PROVIDE FOR A RUN-OFF ELECTION BETWEEN
7	THE TWO PERSONS RECEIVING THE HIGHEST NUMBER OF VOTES; TO ABOLISH
8	THE REQUIREMENT THAT THE GOVERNOR BE ELECTED BY VOTE OF THE HOUSE
9	OF REPRESENTATIVES IF NO PERSON RECEIVES BOTH A MAJORITY OF THE
10	POPULAR VOTE AND A MAJORITY OF THE ELECTORAL VOTES; AND FOR
11	RELATED PURPOSES.

- BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF 12
- MISSISSIPPI, That the following amendments to the Mississippi 13
- Constitution of 1890 are proposed to the qualified electors of the 14
- state: 15
- 16 I.
- 17 Amend Section 140, Mississippi Constitution of 1890, to read as follows: 18
- 19 Section 140. The Governor of the state shall be elected by
- the people in a general election to be held on the first Tuesday 20
- after the first Monday of November of A.D. 2003, and on the first 21
- 22 Tuesday after the first Monday of November in every fourth year
- thereafter. \* \* \* The person receiving a majority of the number 23
- of votes cast in the election for the office shall be declared 24
- 25 elected \* \* \*.
- 26 If no person receives a majority of the votes, then a run-off
- election shall be held three (3) weeks after the general election 27
- between the two (2) persons who received the highest number of 28
- votes. The election shall be held in the same manner and in 29
- 30 accordance with the same procedure, as nearly as practicable, as
- provided by law for a general election. The candidate who 31

receives a majority of the votes in the run-off election shall be 32 33 declared elected. II. 34 35 Amend the Mississippi Constitution of 1890 by repealing 36 Section 141 which reads as follows: 37 Section 141. If no person shall receive such majorities, then the House of Representatives shall proceed to choose a 38 Governor from the two (2) persons who shall have received the 39 highest number of popular votes. The election shall be by viva 40 voce vote, which shall be recorded in the journal, in such manner 41 42 as to show for whom each member voted. 43 Amend the Mississippi Constitution of 1890 by repealing 44 Section 142 which reads as follows: 45 Section 142. In case of an election of Governor or any state 46 officer by the House of Representatives, no member of that House 47 shall be eligible to receive any appointment from the Governor or 48 49 other state officer so elected, during the term for which he shall be elected. 50 51 BE IT FURTHER RESOLVED, That these proposed amendments shall be submitted by the Secretary of State to the qualified electors 52 53 at an election to be held on the first Tuesday after the first Monday of November 2002, as provided by Section 273 of the 54 Constitution and by general law, with the amendments in this 55 56 resolution being voted on as one (1) amendment since the proposed amendments pertain to one (1) subject. 57 BE IT FURTHER RESOLVED, That the explanation of this proposed 58 amendment for the ballot shall read as follows: "This proposed 59 constitutional amendment provides that the person who receives a 60 majority of the popular vote for Governor at the general election 61 shall be declared elected. If no person receives a majority, then 62 63 a run-off election between the two (2) persons receiving the highest number of votes will be held three (3) weeks later.
