SENATE CONCURRENT RESOLUTION NO. 590

1 A CONCURRENT RESOLUTION SUSPENDING THE DEADLINES FOR THE  
 2 PURPOSE OF REQUESTING THE DRAFTING, INTRODUCTION, CONSIDERATION  
 3 AND PASSAGE OF A BILL ENTITLED "AN ACT TO AMEND SECTIONS 43-1-1,  
 4 43-1-2, 43-1-3, 43-1-5 AND 43-1-6, MISSISSIPPI CODE OF 1972, WHICH  
 5 CREATE THE DEPARTMENT OF HUMAN SERVICES, PRESCRIBE ITS DUTIES AND  
 6 RESPONSIBILITIES, PROVIDE FOR THE APPOINTMENT OF AN EXECUTIVE  
 7 DIRECTOR OF HUMAN SERVICES, PROVIDE FOR THE AUTHORITY AND  
 8 RESPONSIBILITIES OF THE EXECUTIVE DIRECTOR, PROVIDE FOR A JOINT  
 9 OVERSIGHT COMMITTEE OF THE DEPARTMENT OF HUMAN SERVICES, PROVIDE  
 10 THE STRUCTURE OF THE DEPARTMENT, AND TRANSFER THE PROGRAMS WITHIN  
 11 THE DIVISION OF FEDERAL-STATE PROGRAMS TO THE STATE DEPARTMENT OF  
 12 HUMAN SERVICES, TO EXTEND THE REPEAL DATES ON THOSE SECTIONS; AND  
 13 FOR RELATED PURPOSES."

14 BE IT RESOLVED BY THE SENATE OF THE STATE OF MISSISSIPPI, THE  
 15 HOUSE OF REPRESENTATIVES CONCURRING THEREIN, That the Joint Rules  
 16 of the Senate and the House are hereby suspended for the purpose  
 17 of requesting the drafting, introduction, consideration and  
 18 passage, regardless of any deadlines imposed by said rules, of a  
 19 bill entitled "AN ACT TO AMEND SECTIONS 43-1-1, 43-1-2, 43-1-3,  
 20 43-1-5 AND 43-1-6, MISSISSIPPI CODE OF 1972, WHICH CREATE THE  
 21 DEPARTMENT OF HUMAN SERVICES, PRESCRIBE ITS DUTIES AND  
 22 RESPONSIBILITIES, PROVIDE FOR THE APPOINTMENT OF AN EXECUTIVE  
 23 DIRECTOR OF HUMAN SERVICES, PROVIDE FOR THE AUTHORITY AND  
 24 RESPONSIBILITIES OF THE EXECUTIVE DIRECTOR, PROVIDE FOR A JOINT  
 25 OVERSIGHT COMMITTEE OF THE DEPARTMENT OF HUMAN SERVICES, PROVIDE
