SENATE CONCURRENT RESOLUTION NO. 616

1 A CONCURRENT RESOLUTION INCORPORATING THE SHORT, LONG AND  
2 SPLIT PRECINCT BLOCK LISTS PRODUCED BY THE COMPUTER SYSTEM  
3 MAINTAINED BY THE STANDING JOINT COMMITTEE ON LEGISLATIVE  
4 REAPPORTIONMENT INTO JOINT RESOLUTION NO. 201, 2002 REGULAR  
5 SESSION, AS ADOPTED BY THE LEGISLATURE; AND FOR RELATED PURPOSES.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

7 WHEREAS, on March 19, 2002, the Standing Joint Committee on  
8 Legislative Reapportionment (Joint Committee) adopted and  
9 recommended to the Legislature a plan to reapportion the  
10 Mississippi State Senate; and

11 WHEREAS, the document incorporating the plan adopted by the  
12 Joint Committee is contained in short, long and Split Precinct  
13 Block Lists produced from the computer system maintained by the  
14 Joint Committee bearing the name "Cabell01"; and

15 WHEREAS, the Joint Committee's recommendation was  
16 incorporated into Joint Resolution No. 201, 2002 Regular Session,  
17 which was introduced on March 19, 2002, and referred to the Senate  
18 Elections Committee on March 19, 2002; and

19 WHEREAS, the Senate Elections Committee considered Joint  
20 Resolution No. 201 at a meeting on March 20, 2002, and  
21 incorporated amendments adopted at the meeting in a Committee  
22 Substitute for Joint Resolution No. 201; and

23 WHEREAS, the Committee Substitute for Joint Resolution No.  
24 201 is contained in short, long and Split Precinct Block Lists  
25 produced from the Joint Committee's computer system known as  
26 "CabellTJ"; and

27 WHEREAS, on March 20, 2002, the Mississippi State Senate  
28 considered Joint Resolution No. 201, three amendments were adopted



29 and the Senate passed Joint Resolution No. 201 including such  
30 amendments; and

31 WHEREAS, Joint Resolution No. 201, as passed the Senate, is  
32 contained in short, long and Split Precinct Block Lists produced  
33 from the Joint Committee's computer system bearing the name  
34 "Cabell77"; and

35 WHEREAS, on March 21, 2002, the Mississippi House of  
36 Representatives passed Joint Resolution No. 201, 2002 Regular  
37 Session, as it passed the Senate:

38 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF  
39 MISSISSIPPI, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN, That  
40 the short, long and Split Precinct reports produced by the Joint  
41 Committee's computer system shall be considered a part of and  
42 incorporated into Joint Resolution No. 201, 2002 Regular Session,  
43 as adopted by the Legislature.

44 BE IT FURTHER RESOLVED, That true and correct copies of the  
45 short, long and Split Precinct Block Lists referred to in this  
46 resolution have been transmitted to the Secretary of State by the  
47 Chairman of the Senate Elections Committee and filed in his  
48 office, and are hereby ratified, confirmed and approved.
