

## REPORT OF CONFERENCE COMMITTEE

We, the undersigned conferees, have had under consideration the amendments to the following entitled BILL:

H. B. No. 1317: Budget Contingency Fund; transfer monies from certain special funds into.

We, therefore, respectfully submit the following report and recommendation:

1. That the Senate recede from its Amendment No. 1.
2. That the House and Senate adopt the following amendment:

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

4           **SECTION 1.** The State Treasurer shall transfer to the Budget  
5 Contingency Fund created in Senate Bill No. 2680, 2001 Regular  
6 Session, out of the following enumerated special funds, amounts  
7 listed below for each special fund throughout the period beginning  
8 upon passage of this act and through June 30, 2002:
