

REPORT OF CONFERENCE COMMITTEE

MADAM PRESIDENT AND MR. SPEAKER:

We, the undersigned conferees, have had under consideration the amendments to the following entitled BILL:

S. B. No. 3148: Appropriation; Egg Marketing Bd.

We, therefore, respectfully submit the following report and recommendation:

1. That the House recede from its Amendment No. 1.

2. That the Senate and House adopt the following amendment:

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

5 **SECTION 1.** The following sum of money, or so much thereof as
6 may be necessary, is hereby appropriated, out of any money in the
7 Special Fund in the State Treasury to the credit of the
8 Mississippi Egg Marketing Board, to defray the expenses of said
9 board for the fiscal year beginning July 1, 2002, and ending
10 June 30, 2003..... \$ 76,305.00.

11 **SECTION 2.** Of the funds appropriated under Section 1, not
12 more than the amounts set forth below shall be expended for the
13 respective major objects or purposes of expenditure:

14 MAJOR OBJECTS OF EXPENDITURE:

15 Personal Services:

Total.....	\$ 76,305.00

25 Any transfers or escalations shall be made in accordance with
26 the terms, conditions, and procedures established by law.

27 No general funds authorized to be expended herein shall be
28 used to replace federal funds and/or other special funds which are
29 being used for salaries authorized under the provisions of this
30 act and which are withdrawn and no longer available.

31 **SECTION 3.** The money herein appropriated shall be paid by
32 the State Treasurer out of any money in the State Treasury to the
33 credit of the proper fund or funds as set forth in this act, upon
34 warrants issued by the State Fiscal Officer; and the State Fiscal
35 Officer shall issue his warrants upon requisitions signed by the
36 proper person, officer or officers in the manner provided by law.

37 **SECTION 4.** This act shall take effect and be in force from
38 and after July 1, 2002.
