REPORT OF CONFERENCE COMMITTEE

We, the undersigned conferees, have had under consideration the amendments to the following entitled BILL:

S. B. No. 3155: Appropriation; Alcorn State-Agricultural Programs.

We, therefore, respectfully submit the following report and recommendation:

- 1. That the House recede from its Amendment No. 1.
- 2. That the Senate and House adopt the following amendment:

Amend by striking all after the enacting clause and inserting in lieu thereof the following:

- SECTION 1. The following sum, or so much thereof as may be 5 necessary, is hereby appropriated out of any money in the State 6 7 General Fund not otherwise appropriated, for the support and maintenance of the Alcorn State University Agricultural Programs 8 9 for the fiscal year beginning July 1, 2002, and ending 10 June 30, 2003.....\$ 4,288,719.00. SECTION 2. The following sum, or so much thereof as may be 11 necessary, is hereby authorized for expenditure out of any special 12 source funds which are collected by or otherwise become available, 13 for the support and maintenance of the Alcorn State University 14 Agricultural Programs for the fiscal year beginning July 1, 2002, 15 and ending June 30, 2003.....\$ 526,097.00. 16 17 SECTION 3. Of the funds appropriated in Section 2, Twenty-one Thousand Ninety-seven Dollars (\$21,097.00) shall be 18 derived from funds in the Education Enhancement Fund deposited 19 pursuant to Sections 27-65-75 and 27-67-31, Mississippi Code of 20 1972. 21
- 22 **SECTION 4.** No general funds authorized to be expended herein
- 23 shall be used to replace federal funds and/or other special funds
- 24 which are being used for salaries which are withdrawn and no
- 25 longer available.

35	the funds appropriated in Sections 1 and 2, an amount of Two	
36	Hundred Thousand Dollars (\$200,000.00) shall be used for the	
37	Mississippi Natural Products Association, Incorporated.	
38	SECTION 8. Of the funds appropriated under the provisions of	
39	Section 2, Fifty-five Thousand Dollars (\$55,000.00) shall be	
40	derived from the Budget Contingency Fund created in Section	
41	27-103-301, Mississippi Code of 1972.	
12	SECTION 9. The money herein appropriated shall be paid by	
43	the State Treasurer out of any money in the State Treasury to the	
44	credit of the proper fund or funds as set forth in this act, upon	
45	warrants issued by the State Fiscal Officer; and the State Fiscal	
46	Officer shall issue his warrants upon requisitions signed by the
