Amend by striking all after the enacting clause and inserting in lieu thereof the following:

5	SECTION 1. The following sum, or so much thereof as may be
6	necessary, is hereby appropriated out of any money in the State
7	General Fund not otherwise appropriated, for the support and
8	maintenance of the Alcorn State University Agricultural Programs
9	for the fiscal year beginning July 1, 2002, and ending
10	June 30, 2003\$ 4,269,543.00
11	SECTION 2. The following sum, or so much thereof as may be
12	necessary, is hereby authorized for expenditure out of any special
13	source funds which are collected by or otherwise become available,
14	for the support and maintenance of the Alcorn State University
15	Agricultural Programs for the fiscal year beginning July 1, 2002,
16	and ending June 30, 2003\$ 471,097.00
17	SECTION 3. Of the funds appropriated in Section 2,
18	Twenty-one Thousand Ninety-seven Dollars (\$21,097.00) shall be
19	derived from funds in the Education Enhancement Fund deposited
20	pursuant to Sections 27-65-75 and 27-67-31, Mississippi Code of
21	1972.
22	SECTION 4. No general funds authorized to be expended herein
23	shall be used to replace federal funds and/or other special funds
24	which are being used for salaries which are withdrawn and no

- 25 longer available.
- 26 **SECTION 5.** It is the intention of the Legislature that the
- 27 agency's budget request for Fiscal Year 2004 shall be submitted to
- 28 the Joint Legislative Budget Committee in a format and level of
- 29 detail comparable to the format and level of detail provided
- 30 during the Fiscal Year 2003 budget request process.
- 31 **SECTION 6.** Of the funds appropriated in Section 1, the
- 32 amount of One Hundred Twenty-eight Thousand Nine Hundred Sixty-
- 33 five Dollars (\$128,965.00) is made available to the Alcorn State
- 34 University Agricultural Programs subject to the passage of House
- 35 Bill No. 1379, 2002 Regular Session. In the event that House Bill
- 36 No. 1379 is not enacted into law, then this appropriation shall be
- 37 reduced by One Hundred Twenty-eight Thousand Nine Hundred Sixty-
- 38 five Dollars (\$128,965.00) in general funds.
- 39 **SECTION 7.** The money herein appropriated shall be paid by
- 40 the State Treasurer out of any money in the State Treasury to the
- 41 credit of the proper fund or funds as set forth in this act, upon
- 42 warrants issued by the State Fiscal Officer; and the State Fiscal
- 43 Officer shall issue his warrants upon requisitions signed by the
- 44 proper person, officer or officers in the manner provided by law.
- 45 **SECTION 8.** This act shall take effect and be in force from
- 46 and after July 1, 2002.
