- 3 SECTION *. Section 59-21-3, Mississippi Code of 1972, is
- 4 amended as follows:
- 5 59-21-3. As used in this chapter, unless the context clearly
- 6 requires a different meaning:
- 7 (a) "Commission" means the Mississippi Commission on
- 8 Wildlife, Fisheries and Parks.
- 9 (b) "Length" means the length of the vessel measured
- 10 from end to end over the deck excluding sheer.
- 11 (c) "Livery boat" means any boat for rent or hire.
- 12 (d) "Machinery" means inboard and outboard engines and
- 13 all other types of motors or mechanical devices.
- 14 (e) "Motorboat" means any undocumented vessel propelled
- 15 by machinery, whether or not such machinery is the principal
- 16 source of propulsion. The term motorboat includes personal
- 17 watercraft.
- 18 (f) "Operate" means to navigate or otherwise use a
- 19 motorboat or vessel.
- 20 (g) "Operator" means the person who operates or who has
- 21 charge of the navigation or use of a motorboat or a vessel.
- (h) "Owner" means the person who claims lawful
- 23 possession of a vessel by virtue of legal title or equitable

- 24 interest therein which entitles him to such possession.
- 25 (i) "Person" means an individual, partnership, firm,
- 26 corporation, association or other entity.
- 27 (j) "Personal watercraft" means a vessel which uses an
- 28 <u>inboard motor powering a water jet pump as its primary source of</u>
- 29 motive power and which is designed to be operated by a person
- 30 sitting, standing, or kneeling on the vessel, rather than the
- 31 <u>conventional manner of sitting or standing inside the vessel.</u>
- 32 <u>(k)</u> "Ships' lifeboats" means lifeboats used solely for
- 33 lifesaving purposes and does not include dinghies, tenders,
- 34 speedboats, or other type of craft carried aboard a vessel and
- 35 used for other than lifesaving purposes.
- 36 (1) "Undocumented vessel" means any vessel which is not
- 37 required to have, and does not have, a valid marine document
- 38 issued by the Bureau of Customs.
- 39 (m) "Vessel" means every description of watercraft,
- 40 other than seaplane on the water, used or capable of being used as
- 41 a means of transportation on water.
- 42 <u>(n)</u> "Waters of this state" means any waters within the
- 43 territorial limits of this state, and the marginal sea adjacent to
- 44 this state and the high seas when navigated as a part of a journey
- 45 or ride to or from the shore of the state; however, "waters of
- 46 this state" does not mean any private pond or lake which is not
- 47 used for boat rentals or the charging of fees for fishing therein.
