6	BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

Funds are provided herein to adjust the Variable Compensation 127 Plan to ensure that all full-time employees receive a pay increase 128 equal to fifty percent (50%) of the realignment component of the 129 130 Variable Compensation Plan or Six Hundred Dollars (\$600.00), 131 whichever is greater, beginning on January 1, 2003. 132 With the funds herein appropriated, it is the intention of the Legislature that it shall be the agency's responsibility to 133 make certain that funds required to be appropriated for "Personal 134 Services" for Fiscal Year 2004 do not exceed Fiscal Year 2003 135 funds appropriated for that purpose, unless programs, positions or 136 137 pay increases are added to the agency's budget by the Mississippi Legislature. Based on data provided by the Legislative Budget 138 Office, the State Personnel Board shall, on July 1, 2002, publish 139 separate annual projection reports, based on July 1, 2002 data, 140 for the period of July 1, 2002, through December 31, 2002, and 141 January 1, 2003, through June 30, 2003, that project the annual 142 cost to fully fund all appropriated positions in compliance with 143 144 the provisions of this act. It shall be the responsibility of the agency head to ensure that no single personnel action increases 145 146 this projected cost and/or the Fiscal Year 2003 appropriation for 147 "Personal Services," as annualized on a semiannual basis in 148 accordance with the provisions of this act. If, at the end of any calendar month, the State Personnel Board determines that the 149 agency has taken action(s) which would cause the agency to exceed 150 151 this projected annual cost or the Fiscal Year 2003 "Personal Services" appropriated level, when annualized in compliance with 152 153 the provisions of this act, then only those actions which reduce the projected annual cost and/or the appropriation requirement 154 will be processed by the State Personnel Board until such time as 155 156 the requirements of this provision are met. Any transfers or escalations shall be made in accordance with 157 158 the terms, conditions and procedures established by law * * *.
