- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- SECTION 1. Section 15-1-13, Mississippi Code of 1972, which 6
- provides that ten (10) years' actual adverse possession of land 7
- vests occupant or possessor with full title to such land, is 8
- 9 repealed.

- SECTION 2. Section 89-1-55, Mississippi Code of 1972, is 10
- 12 89-1-55. All lands comprising a single tract and wholly
- described by the subdivisions of the governmental surveys, sold 13
- under mortgages and deeds of trust, shall be sold in the manner 14
- provided by Section 111 of the Constitution for the sale of lands 15
- in pursuance of a decree of court or under execution. All lands 16
- 17 sold at public outcry under deeds of trust or other contracts
- shall be sold in the county in which the land is located or in the 18
- county of the residence of the grantor, or one (1) of the grantors 19
- in the trust deed provided that where the land is situated in two 20
- 21 (2) or more counties, the parties may contract for a sale of the
- whole in any of the counties in which any part of the land lies. 22
- Sale of the lands shall be advertised for three (3) consecutive 23
- weeks preceding such sale in a newspaper published in the county 24
- or, if none is so published, in some paper having a general 25
- 26 circulation therein and by posting one (1) notice at the
- courthouse of the county where the land is situated, for such 27
- time, and such notice and advertisement shall disclose the name of 28

- 29 the original mortgagor or mortgagors in the deed of trust or other
- 30 contract. No sale of lands under a deed of trust or mortgage
- 31 shall be valid unless such sale was advertised as * * * provided
- 32 <u>herein</u> regardless of any contract to the contrary. An error in
- 33 the mode of sale such as makes the sale void shall not be cured by
- 34 any statute of limitations * * *.
- 35 **SECTION 3.** This act shall take effect and be in force from
- 36 and after July 1, 2003.
