HOUSE BILL NO. 425

- AN ACT TO AMEND SECTION 63-3-603, MISSISSIPPI CODE OF 1972, 1
- TO REQUIRE VEHICLES TO BE DRIVEN IN THE RIGHT-HAND LANE ON 2
- 3 ROADWAYS DIVIDED INTO FOUR OR MORE LANES FOR TRAFFIC; AND FOR
- 4 RELATED PURPOSES.
- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 5
- SECTION 1. Section 63-3-603, Mississippi Code of 1972, is 6
- amended as follows: 7
- 63-3-603. Whenever any roadway has been divided into three 8
- 9 (3) or more clearly marked lanes for traffic, except through or
- bypassing a municipality, the following rules in addition to all 10
- others consistent herewith shall apply: 11
- (a) A vehicle shall be driven as nearly as practical 12
- entirely within a single lane and shall not be moved from such 13
- lane until the driver has first ascertained that such movement can 14
- be made with safety. 15
- A vehicle shall not be driven in the center lane 16
- upon a roadway which is divided into three (3) lanes except when: 17
- (i) Overtaking and passing another vehicle where 18
- the roadway is clearly visible and such center lane is clear of 19
- traffic within a safe distance; 20
- (ii) Such vehicle is in preparation for a left 21
- turn; or 22
- (iii) Such center lane is at the time allocated 23
- exclusively to traffic moving in the direction such vehicle is 24
- proceeding and is signposted to give notice of such allocation. 25
- 26 (c) Official signs may be erected directing slow-moving
- traffic to use a designated lane or allocating specified lanes to 27

- 28 traffic moving in the same direction, and drivers of vehicles
- 29 shall obey the directions of every such sign.
- 30 (d) Upon all roadways any vehicle proceeding at less
- 31 than the normal speed of traffic at the time and place and under
- 32 the conditions then existing shall be driven in the right-hand
- 33 lane then available for traffic, or as close as practicable to the
- 34 right-hand curb or edge of the roadway, except when overtaking and
- 35 passing another vehicle proceeding in the same direction or when
- 36 preparing for a left turn at an intersection or into a private
- 37 road or driveway.
- 38 (e) Whenever any roadway is divided into four (4) or
- 39 more lanes for traffic, every vehicle shall be driven in the
- 40 right-hand lane nearest the edge of the roadway except when
- 41 overtaking and passing another vehicle proceeding in the same
- 42 direction or except when preparing for a left turn or exit to the
- 43 left.
- 44 (f) Persons riding bicycles upon a roadway shall not
- 45 ride more than two (2) abreast except on paths or parts of
- 46 roadways set aside for the exclusive use of bicycles. Persons
- 47 riding two (2) abreast shall not impede the normal and reasonable
- 48 movement of traffic and, on a laned roadway, shall ride within a
- 49 single lane.
- 50 **SECTION 2.** This act shall take effect and be in force from
- 51 and after July 1, 2003.
