HOUSE BILL NO. 553

AN ACT TO CREATE THE MISSISSIPPI SMOKE FREE FAMILY RESTAURANT
ACT; TO PROVIDE DEFINITIONS OF CERTAIN TERMS; TO PROHIBIT SMOKING
IN ALL FAMILY RESTAURANTS IN THE STATE OF MISSISSIPPI; TO ALLOW
SMOKING IN BARS THAT ARE PART OF FAMILY RESTAURANTS IF THE BARS
ARE CLOSED OFF TO THE MAIN SEATING AREA OF THE RESTAURANT WITH
OOORS OR FULL WALLS; TO PROVIDE FOR THE POSTING OF NO SMOKING
SIGNS AT FAMILY RESTAURANTS; TO DIRECT THE STATE BOARD OF HEALTH

- 8 TO ADOPT REGULATIONS AND PENALTIES REGARDING VIOLATIONS OF THIS
- 9 ACT; AND FOR RELATED PURPOSES.
- 10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 11 SECTION 1. This act shall be known and may be cited as the
- 12 "Mississippi Smoke Free Family Restaurant Act."
- 13 SECTION 2. As used in this act, the following words and
- 14 phrases shall have the meanings ascribed in this section, unless
- 15 the context clearly indicates otherwise:
- 16 (a) "Bar" means an area that is devoted to the serving
- 17 of alcoholic beverages for consumption by guests on the premises,
- 18 in which the serving of food is only incidental to the consumption
- 19 of those beverages.
- 20 (b) "Enclosed" means enclosed on all sides by solid
- 21 walls or windows, excluding doors or passageways, that extend from
- 22 the floor to the ceiling.
- 23 (c) "Family restaurant" means any indoor or enclosed
- 24 eating establishment that gives or offers for sale food to the
- 25 public and allows persons under eighteen (18) years of age to
- 26 enter and be served.
- 27 (d) "Smoking" means inhaling, exhaling, burning,
- 28 carrying or otherwise possessing any lighted cigarette, cigar,
- 29 pipe or any other object or device of any form that contains
- 30 lighted tobacco or any other smoking product.

- 31 **SECTION 3.** (1) Smoking is prohibited in all family
- 32 restaurants in the State of Mississippi.
- 33 (2) Notwithstanding the provision of subsection (1) of this
- 34 section:
- 35 (a) A family restaurant is not subject to the smoking
- 36 restrictions of this act while the entire restaurant is being used
- 37 for a private function.
- 38 (b) A bar that is part of a family restaurant is not
- 39 subject to the smoking restrictions of this act if the bar is a
- 40 separate enclosed area that is closed off to the main seating area
- 41 of the restaurant with doors or full walls, and tobacco smoke from
- 42 the bar cannot filter into the main seating area of the restaurant
- 43 through a ventilation system.
- 44 (3) Every family restaurant shall have posted at every
- 45 entrance a conspicuous sign clearly stating that smoking is
- 46 prohibited in the restaurant.
- 47 SECTION 4. The State Board of Health shall adopt and
- 48 promulgate regulations and penalties regarding the violations of
- 49 this act not later than ninety (90) days after the effective date
- 50 of this act.
- 51 **SECTION 5.** This act shall not be interpreted or construed to
- 52 prohibit any municipality or county from adopting ordinances with
- 53 regard to smoking in restaurants or other public places.
- 54 **SECTION 6.** This act shall take effect and be in force from
- 55 and after its passage.
