HOUSE BILL NO. 683

1 AN ACT TO AMEND SECTION 25-3-33, MISSISSIPPI CODE OF 1972, TO
2 REMOVE THE DIRECTOR OF THE DIVISION OF MEDICAID FROM THE OMNIBUS
3 PAY SECTION; AND FOR RELATED PURPOSES.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

5 **SECTION 1.** Section 25-3-33, Mississippi Code of 1972, is
