HOUSE BILL NO. 747

1 AN ACT TO AMEND SECTION 25-3-33, MISSISSIPPI CODE OF 1972, TO  
2 INCREASE THE SALARY AUTHORIZED TO BE PAID TO THE EXECUTIVE  
3 DIRECTOR OF THE PEARL RIVER VALLEY WATER SUPPLY DISTRICT; AND FOR  
4 RELATED PURPOSES.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

6 **SECTION 1.** Section 25-3-33, Mississippi Code of 1972, is
