HOUSE BILL NO. 777 (As Passed the House)

AN ACT TO AMEND SECTION 41-89-3, MISSISSIPPI CODE OF 1972, TO EXTEND THE REPEALER ON CERTAIN PROVISIONS APPLICABLE TO THE INFANT MORTALITY TASK FORCE; AND FOR RELATED PURPOSES.

- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 5 **SECTION 1.** Section 41-89-3, Mississippi Code of 1972, is
- 6 amended as follows:
- 7 41-89-3. (1) The Chairman of the Infant Mortality Task
- 8 Force shall be elected annually by the task force membership. The
- 9 task force shall adopt bylaws and rules for its efficient
- 10 operation, which may include designation of its organizational
- 11 structure including other officers and committees, duties of
- 12 officers and committees, a process for selecting officers, quorum
- 13 requirements for committees, provisions for special or ad hoc
- 14 committees, staff policies and other such procedures as may be
- 15 necessary. The task force may establish committees responsible
- 16 for conducting specific task force programs or activities.
- 17 (2) The task force shall be assigned to the State Department
- 18 of Health for administrative purposes only, and the department
- 19 shall designate staff to assist the task force. The task force
- 20 shall have a line item in the budget of the State Department of
- 21 Health and shall be financed through the department's annual
- 22 appropriation. Members of the task force may receive, within the
- 23 funds appropriated, reimbursement for travel expenses incurred
- 24 while engaged in official business of the task force.
- 25 (3) The task force shall meet and conduct business at least
- 26 quarterly. All meetings of the task force and any committees of
- 27 the task force shall be open to the public, with opportunities for

- 28 public comment provided on a regular basis. Notice of all
- 29 meetings shall be given as provided in the Open Meetings Act
- 30 (Section 25-41-1 et seq.) and appropriate notice also shall be
- 31 given to all persons so requesting of the date, time and place of
- 32 each meeting.
- 33 (4) The Infant Mortality Task Force, in conjunction with the
- 34 State Department of Health, the Department of Human Services, the
- 35 State Department of Education and the Division of Medicaid, shall
- 36 develop and implement a campaign for intensive outreach to high
- 37 risk populations in Mississippi to encourage them to avail
- 38 themselves of family planning, prenatal care and infant health
- 39 services.
- 40 (5) The Infant Mortality Task Force may apply for and expend
- 41 grants or other contributions for the purpose of promoting
- 42 maternal and infant health in Mississippi.
- 43 (6) This section shall stand repealed on July 1, 2005.
- 44 **SECTION 2.** This act shall take effect and be in force from
- 45 and after July 1, 2003.
