HOUSE BILL NO. 938

- AN ACT TO AMEND SECTION 49-15-63, MISSISSIPPI CODE OF 1972, 1
- TO ALLOW THE COMMISSION ON MARINE RESOURCES TO SUSPEND THE LICENSE 3
- OF PERSONS CONVICTED OF A MARINE VIOLATION AND TO SUSPEND THE LICENSE OF VESSELS USED IN THE VIOLATION; AND FOR RELATED 4
- 5 PURPOSES
- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 6
- 7 SECTION 1. Section 49-15-63, Mississippi Code of 1972, is
- amended as follows: 8
- 9 49-15-63. (1) (a) Any person, firm or corporation
- violating any of the provisions of this chapter or any ordinance 10
- duly adopted by the commission, unless otherwise specifically 11
- provided for herein, shall, on conviction, be fined not less than 12
- One Hundred Dollars (\$100.00), nor more than Five Hundred Dollars 13
- 14 (\$500.00), for the first offense, unless the first offense is
- committed during a closed season, in which case the fine shall be 15
- not less than Five Hundred Dollars (\$500.00), nor more than One 16
- Thousand Dollars (\$1,000.00); and not less than Five Hundred 17
- Dollars (\$500.00), nor more than One Thousand Dollars (\$1,000.00), 18
- for the second offense when such offense is committed within a 19
- period of three (3) years from the first offense; and not less 20
- than Two Thousand Dollars (\$2,000.00) nor more than Four Thousand 21
- 22 Dollars (\$4,000.00), or imprisonment in the county jail for a
- period not exceeding thirty (30) days for any third or subsequent 23
- offense when such offense is committed within a period of three 24
- (3) years from the first offense. 25
- In addition, upon conviction of such third or 26
- 27 subsequent offense, it shall be the duty of the court to revoke
- the license of the convicted party and of the boat or vessel used 28

- 29 in such offense, and no further license shall be issued to such
- 30 person and for said boat to engage in catching or taking of any
- 31 seafoods from the waters of the State of Mississippi for a period
- 32 of one (1) year following such conviction. Forfeiture of any
- 33 equipment or nets used in a second or subsequent offense may be
- 34 instituted pursuant to Sections 49-15-201 through 49-15-207. If
- 35 the person in possession of or using the nets in the violation is
- 36 not the owner or licensee of the nets, the department shall notify
- 37 the owner or licensee of the nets. The nets shall be subject to
- 38 forfeiture unless the nets were stolen and prosecution for the
- 39 theft is initiated. Equipment as used in this section shall not
- 40 mean boats or vessels.
- 41 (c) Any person convicted and sentenced under this
- 42 section for a second or subsequent offense shall not be considered
- 43 for * * * reduction of sentence.
- (d) Except as provided under subsection (5) of Section
- 45 49-15-45, any fines collected under this section shall be paid
- 46 into the Seafood Fund.
- 47 (e) In addition to any other penalties, the commission
- 48 may suspend the license of any person convicted of a violation of
- 49 this chapter and may suspend the license of any vessel used in the
- 50 violation for a period not to exceed five (5) days for the first
- 51 offense. For a second offense, the commission may suspend the
- 52 license of such person and vessel for a period not to exceed
- 53 thirty (30) days.
- 54 (2) For any violation of this chapter, the individual
- 55 registered as the captain of a freight boat, ice boat or catching
- 56 boat used in catching or transporting of saltwater shrimp shall be
- 57 subject to the penalties provided in this chapter, if that
- 58 individual is aboard the vessel. If that individual is not aboard
- 59 the vessel, the individual designated as the substitute captain in
- 60 accordance with Section 49-15-64.5 shall be subject to the
- 61 penalties provided in this chapter. If no individual is

- designated under Section 49-15-64.5, the person, firm or
- 63 corporation owning the vessel shall be subject to the penalties
- 64 provided for boat captains.
- 65 (3) All citations issued to boat operators for not
- 66 possessing the boat's registration card shall be dismissed, along
- 67 with all related court costs, upon the presentment of the boat's
- 68 proper registration card to the court or magistrate holding the
- 69 trial or hearing.
- 70 **SECTION 2.** This act shall take effect and be in force from
- 71 and after July 1, 2003.
