## HOUSE BILL NO. 967

AN ACT TO AMEND SECTION 29-19-56.12, MISSISSIPPI CODE OF 1 1972, TO PROVIDE THAT THE ADDITIONAL FEE FOR ISSUANCE OF A 3

DISTINCTIVE LICENSE TAG TO HONORABLY DISCHARGED VETERANS WHO

4 SERVED IN THE UNITED STATES ARMED SERVICES SHALL BE DUE ONLY UPON INITIAL APPLICATION; AND FOR RELATED PURPOSES. 5

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 6

7 SECTION 1. Section 27-19-56.12, Mississippi Code of 1972, is

amended as follows: 8

27-19-56.12. In recognition of the patriotic service 9

rendered by Mississippians who are honorably discharged veterans 10

who served in the United States Armed Forces, any such person is

privileged to obtain distinctive motor vehicle license plates or 12

tags for each motor vehicle registered in his name identifying his 13

14 status as a veteran. The State Tax Commission, with concurrence

by the State Veterans Affairs Board, shall develop decals to be 15

affixed to the license tag indicating branch and period of 16

military service. The distinctive plates or tags shall be of a 17

color and design designated by the Tax Commission with concurrence 18

by the State Veterans Affairs Board. 19

The distinctive license plates shall be prepared by the Tax 20

Commission and shall be issued through the tax collectors of the 21

22 counties in the same manner as are other motor vehicle license

plates or tags. An additional one-time tag fee of Thirty Dollars 23

(\$30.00) shall be collected by the tax collector for such license 24

plates or tags and shall be remitted to the Tax Commission on a 25

monthly basis as prescribed by the commission. \* \* \* The State 26

27 Tax Commission shall deposit such fee to the credit of a fund to

be administered by the board overseeing the veterans nursing homes 28

- 29 in this state for the benefit of indigent veterans who are
- 30 residents of such nursing homes.
- 31 An applicant for such distinctive plates shall present to the
- 32 issuing official written evidence of the veteran's service. Such
- 33 evidence shall include a copy of the applicant's DD-214 form, a
- 34 Report of Separation from Military Service, a military discharge
- 35 document, or a written certification of military service from the
- 36 State Veterans Affairs Board. The distinctive license plates or
- 37 tags so issued shall be used only upon a personally or jointly
- 38 owned private passenger vehicle (to include station wagons,
- 39 recreational motor vehicles and pickup trucks) registered in the
- 40 name, or jointly in the name, of the person making application
- 41 therefor, and when issued to such person shall be used upon the
- 42 vehicle for which issued in lieu of the standard license plate or
- 43 license tag normally issued for such vehicle.
- The distinctive license plates shall not be transferable
- 45 between motor vehicle owners; and in the event the owner of a
- 46 vehicle bearing a distinctive plate shall sell, trade, exchange or
- 47 otherwise dispose of the vehicle, such plate shall be retained by
- 48 such owner and returned to the tax collector.
- 49 **SECTION 2**. This act shall take effect and be in force from
- 50 and after July 1, 2003.
