HOUSE BILL NO. 1154

AN ACT TO AMEND SECTION 63-7-83, MISSISSIPPI CODE OF 1972, TO 1 REQUIRE EVERY TRUCK HAVING A GROSS VEHICLE WEIGHT OF 10,000 POUNDS 2 OR MORE, EVERY TRAILER AND EVERY OTHER COMMERCIAL CARRIER OF PROPERTY WITH AN OPEN TOP, WHILE TRAVELING UPON ANY PUBLIC HIGHWAY, ROAD OR STREET IN THIS STATE, AND WHILE CARRYING ANY LOAD 3 4 5 OF SAND, DIRT, GRAVEL, ROCK, WOOD CHIPS OR OTHER NATURAL, ARTIFICIAL OR SYNTHETIC PRODUCT HAVING A LIKELIHOOD OF FALLING OR 6 7 DISLODGING FROM OR BLOWING OUT OF THE VEHICLE TO BE EQUIPPED WITH A TARPAULIN, CANVAS OR OTHER SUCH TOP SECURED OVER THE TOP OF THE 8 9 LOAD; TO AMEND SECTION 63-7-89, MISSISSIPPI CODE OF 1972, IN CONFORMITY TO THE PROVISIONS OF THIS ACT; TO REPEAL SECTION 10 11 63-7-85, MISSISSIPPI CODE OF 1972, WHICH AUTHORIZES OPEN TOP 12 TRUCKS, TRAILERS AND CARRIERS OF VEHICLES HAULING SAND, DIRT, GRAVEL OR ROCKS TO USE SIDEBOARDS IN LIEU OF TARPAULINS TO COVER 13 14 THEIR LOAD WHEN TRAVELING UPON STATE AND FEDERAL HIGHWAYS; AND FOR 15 16 RELATED PURPOSES.

17BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:18SECTION 1. Section 63-7-83, Mississippi Code of 1972, is

19 amended as follows:

63-7-83. Every truck having a gross vehicle weight of ten 20 thousand (10,000) pounds or more, every trailer and every other 21 commercial carrier of property with an open top, while traveling 22 upon any public highway, road or street in this state, * * * and 23 while carrying any load of sand, dirt, gravel, rock, wood chips or 24 25 other natural, artificial or synthetic product having a likelihood of falling or dislodging from or blowing out of the vehicle shall 26 be equipped with a tarpaulin, canvas or other such top * * * 27 secured over the top of the load * * *. 28 SECTION 2. Section 63-7-89, Mississippi Code of 1972, is 29

30 amended as follows:

63-7-89. Any person, firm or corporation <u>convicted for a</u>
violation of * * * Section 63-7-85, is guilty of a misdemeanor
and, upon conviction, shall be fined not less than Twenty-five

36 **SECTION 3.** Section 63-7-85, Mississippi Code of 1972, which 37 authorizes open top trucks, trailers and carriers of vehicles 38 hauling sand, dirt, gravel or rocks to use sideboards in lieu of 39 tarpaulins to cover their load when traveling upon state and 40 federal highways, is repealed.

41 **SECTION 4.** This act shall take effect and be in force from 42 and after July 1, 2003.
