COMMITTEE SUBSTITUTE FOR HOUSE BILL NO. 1241

AN ACT TO CREATE THE POSITION OF SCHOOL RESOURCE OFFICER UNDER THE STATE DEPARTMENT OF EDUCATION AS A FIVE-YEAR PILOT 3 PROGRAM; TO REQUIRE THE PROGRAM TO BE IMPLEMENTED IN SCHOOL DISTRICTS CHARACTERIZED BY POOR STUDENT PERFORMANCE, HIGH CRIME RATES OR DELINQUENT ACTS; TO PROVIDE THAT THE STATE DEPARTMENT OF EDUCATION SHALL ESTABLISH THE MINIMUM QUALIFICATIONS AND SALARY 7 FOR SCHOOL RESOURCE OFFICERS; TO AUTHORIZE SCHOOL RESOURCE OFFICERS TO USE SCHOOL FACILITIES IN THE PERFORMANCE OF THEIR 8 DUTIES; TO PROVIDE THAT EACH SCHOOL RESOURCE OFFICER SHALL 9 10 IMPLEMENT A MENTORING PROGRAM IN ORDER TO PROVIDE STUDENTS WITH 11 POSITIVE ROLE MODELS FROM THE LOCAL COMMUNITY; TO REQUIRE EACH SCHOOL RESOURCE OFFICER TO ESTABLISH A YOUTH CRIME WATCH PROGRAM 12 TO HELP YOUTH IN THE PREVENTION OF VIOLENCE, DRUG AND ALCOHOL USE AND GANG ACTIVITY AND SMOKING CESSATION; TO DESCRIBE THE 13 14 ORGANIZATION AND FUNCTIONS OF THE YOUTH CRIME WATCH PROGRAM; TO 15 PROVIDE FOR THE IMPLEMENTATION BY THE SCHOOL RESOURCE OFFICER OF A 16 CONFLICT RESOLUTION PROGRAM TO TEACH CHILDREN TO PEACEFULLY 17 18 RESOLVE CONFLICTS AND TO EFFECTIVELY DEAL WITH ANGER; TO PROVIDE FOR THE IMPLEMENTATION OF A MENTORING GROUP FOR STUDENTS BETWEEN 19 20 THE AGES OF TEN AND FOURTEEN WITH ACADEMIC OR BEHAVIORAL PROBLEMS; TO REQUIRE STUDENTS IN THE PROGRAM TO PARTICIPATE IN SCHOOL AND 21 COMMUNITY PROJECTS AND A PERFORMANCE GROUP; TO REQUIRE THE STATE 22 DEPARTMENT OF EDUCATION TO EVALUATE THE EFFECTIVENESS OF THE 23 SCHOOL RESOURCE OFFICER BEFORE JANUARY 1, 2008, AND TO RECOMMEND TO THE LEGISLATURE THE IMPLEMENTATION OF THE POSITION IN ALL 2.4 25 SCHOOL DISTRICTS OR ITS DISCONTINUATION; AND FOR RELATED PURPOSES. 26 27 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: **SECTION 1.** (1) There is created as a pilot program within 28

the State Department of Education the position of school resource 29 30 officer. The school resource officer shall be responsible for the administration of various interdiction programs and the 31 coordination of local collaborative efforts for at-risk children 32 in the school district to which the school resource officer is 33 34 assigned by the department.

(2) The State Department of Education shall implement the position of school resource officer as a pilot program in selected school districts in the state. Any school district that has been placed on probation for failure to meet accreditation standards since July 1, 1999, shall be given first priority to be included H. B. No. 1241 G1/2

- 40 in the program. The department shall designate the remainder of
- 41 the districts for participation in the pilot program by
- 42 identifying those districts most characterized by poor student
- 43 performance, high incidents of crime or delinquent acts. The
- 44 pilot program shall exist until July 1, 2008, at which time, based
- 45 upon the recommendations of the department, the position must be
- 46 permanently established in all school districts or discontinued.
- 47 (3) The State Department of Education shall establish the
- 48 minimum qualifications and annual salary for the position of
- 49 school resource officer. The school resource officer shall
- 50 maintain an office in the school district to which the officer is
- 51 assigned by the department. The department may authorize the
- 52 employment of any clerical or support personnel that may be
- 53 necessary for the administration of the office of the school
- 54 resource officer.
- 55 (4) The school resource officer may use school buildings and
- 56 grounds within the school district for the holding of meetings and
- 57 gatherings of people in the performance of his duties.
- 58 **SECTION 2.** In order to provide students with an opportunity
- 59 to have direct personal contact with positive role models from
- 60 within the local community, the school resource officer shall
- 61 develop and implement a mentoring program that demonstrates the
- 62 accomplishments of local citizens. The mentoring program shall
- 63 coordinate the activities of school personnel, members of the
- 64 business community, civic leaders, law enforcement, churches and
- other organizations to present various programs to student groups
- 66 and tutorial and guidance services to individual students.
- 67 **SECTION 3.** (1) Each school resource officer shall be
- 68 responsible for establishing a Youth Crime Watch Program in the
- 69 school district to which the officer is assigned to help youth in
- 70 the prevention of crime and violence, alcohol and drug use and
- 71 gang activity and smoking cessation. The Youth Crime Watch

72 Program must be a school-based, peer group organization comprised

and under the leadership of students. Through the program, 73 students shall promote student responsibility for a safe school 74 environment through formal and informal peer groups. 75 In addition, 76 the program shall focus on the consequences of youth crime and 77 what students can do to prevent it. The school resource officer shall provide guidance to the students in the formation of the 78 program and must be available, upon the request of the students, 79 to assist with the various activities conducted through the 80 81 program. In the Youth Crime Watch Program, a core group 82

83 consisting of an advisor, Youth Crime Watch representative, students selected by the principal or staff and other program 84 85 participants must be formed at each school. The core group members shall serve as representatives of the program to all 86 87 students, who must be encouraged to participate in the program. Activities and responsibilities of the group must include defining 88 the school's needs and problems, promoting school spirit, 89 90 developing action plans and helping sponsor activities for reducing campus crime, publicizing program successes and 91 92 increasing student involvement. The school resource officer shall encourage the involvement of local businesses and law enforcement 93 94 officials to secure materials and guest speakers to further the 95 work of the Youth Crime Watch Program.

SECTION 4. The school resource officer shall develop and 96 97 implement in all schools in the district a formal conflict resolution program designed to teach children to peacefully 98 resolve conflicts and to effectively deal with their anger. 99 As part of the program, students must be taught how to resolve 100 disagreements nonviolently by working together to arrive at 101 102 mutually acceptable solutions. Students, teachers or parent volunteers also may be trained to settle disputes among students. 103 104 In addition to offering conflict resolution skills, the program 105 shall seek to develop leadership and coping skills in students.

106 The program must be a part of the curriculum of students at each 107 grade level.

- SECTION 5. (1) The school resource officer shall establish 108 109 in each middle or junior high school in the district a school 110 mentoring group for students between the ages of ten (10) and fourteen (14) with academic or behavioral problems. Through this 111 program, participants must have the opportunity to do homework for 112 several hours after school and to take part in group sessions 113 where the students have a safe outlet to discuss with their peers, 114 problems involving various aspects of their lives, including the 115 116 school or community, drug and alcohol use, child abuse, coping with parental and other adult authorities, finances, gang 117 118 activity, emotional crises, peer pressure and health and legal Students must be trained to develop solutions to their 119 issues. problems, including weighing what the consequences of different 120 121 actions in response to a particular problem might be.
- 122 (2) The mentoring program shall require students to
 123 participate in school and community service projects. Through
 124 these projects, students shall perform beneficial services for
 125 their school or community through activities such as preparing
 126 props for a school play or doing chores for the elderly. The
 127 goals of the school and community service projects are to:
- 128 (a) Promote self-esteem, citizenship and other positive 129 qualities in participants;
- 130 (b) Enhance students' sense of empowerment as they make
 131 a contribution to the community;
- 132 (c) Help students develop problem-solving, social and 133 employment skills;
- 134 (d) Foster interaction among students; and
- (e) Provide students with opportunities to give help
- 136 and to receive help from their peers.

- 141 SECTION 6. Before January 1, 2008, the State Department of
- 142 Education shall evaluate those school districts that have
- 143 participated in the pilot program to determine the effectiveness
- 144 of the school resource officer. The evaluation must consider the
- 145 following factors:
- 146 (a) The improvement in academic performance of students
- 147 in the district;
- 148 (b) The degree to which youth crime and school violence
- 149 has decreased;
- 150 (c) The participation rate of students in the various
- 151 programs implemented and administered by the school resource
- 152 officer; and
- 153 (d) The opinions of school administrators, teachers,
- 154 parents and students in regard to the various programs implemented
- 155 and administered by the school resource officer.
- The State Department of Education shall prepare a report
- 157 based upon its evaluation of the pilot program. The report must
- 158 contain a recommendation by the department to the Legislature that
- 159 the program be permanently implemented in all school districts or
- 160 discontinued.
- 161 SECTION 7. This act shall not be implemented unless
- 162 sufficient federal or state funds are available for that purpose.
- 163 **SECTION 8.** This act shall take effect and be in force from
- 164 and after July 1, 2003.
