COMMITTEE SUBSTITUTE FOR HOUSE BILL NO. 1415

AN ACT TO AUTHORIZE THE DELTA CORRECTIONAL FACILITY AUTHORITY 1 IN LEFLORE COUNTY, MISSISSIPPI, THE BOARD OF SUPERVISORS OF 2 LEFLORE COUNTY, MISSISSIPPI, AND THE MISSISSIPPI DEPARTMENT OF CORRECTIONS TO EXCHANGE CERTAIN REAL PROPERTY LOCATED IN LEFLORE 3 4 COUNTY, MISSISSIPPI; AND FOR RELATED PURPOSES. 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 6 7 **SECTION 1.** (1) In consideration for the conveyance of property authorized in Section 2 of this act, the Delta 8 9 Correctional Facility Authority, acting through its Board of Commissioners, is authorized to transfer and convey to the Board 10 of Supervisors of Leflore County, Mississippi, all right, title 11 and interest in and to certain real property and any improvements 12 thereon located in Leflore County, Mississippi, subject to any 13 14 encumbrances, liens, covenants, conditions or restrictions of record pertaining thereto, such parcel of property consisting of 15 approximately three and sixty-four one-hundredths (3.64) acres 16 located in Section 29, Township 19 North, Range 1 East, Leflore 17 County, Mississippi, and described more particularly as follows: 18 19 Begin at an iron pipe marking the northeast corner of said Section 29 and proceed WEST 1249.61 feet to a 20 point, thence SOUTH 2532.23 feet to an iron pipe marking 21 22 the Point of Beginning of the tract herein described, from said Point of Beginning proceed S 47°50'05"E 129.00 23 feet to an iron pipe, thence N 42°09'55"E 194.00 feet to 24 an iron pipe, thence S 69°20'16"E 47.34 feet to an iron 25 pipe, thence S 2°10'17"E 120.47 feet to an iron pipe, 26 27 thence S 42°24'11"West 83.85 feet to an iron pipe, 28 thence S 47°50'05"E 131.06 feet to an iron pipe, thence

43 (2) The Mississippi Department of Corrections is authorized
44 to release the property described in subsection (1) of this
45 section from:

46 (i) The lease agreement entered into between the
47 Delta Correctional Facility Authority and the Mississippi
48 Department of Corrections on June 1, 1995; and

49 (ii) Any additional documents executed in
50 connection with the lease of said property under the Lease
51 Agreement as provided for in connection with the financing of the
52 Delta Correctional Facility.

53 (3) The conveyance authorized in this section may be subject 54 to additional terms and conditions agreed upon by the Delta 55 Correctional Facility Authority and the Mississippi Department of 56 Corrections.

57 <u>SECTION 2.</u> (1) In consideration for the conveyance of 58 property authorized in Section 1 of this act, the Board of 59 Supervisors of Leflore County, Mississippi, is authorized to 60 transfer and convey to the Mississippi Department of Corrections, 61 all right, title and interest in certain real property and any H. Beginning at the intersection of Section line between 64 65 Sections 11 and 12, Township 19, Range 1 East, with the 66 Southern Boundary line of the right of way of the C.& G. Railroad Company, in Mississippi, and run thence North 67 89 degrees and 32 minutes East with said C. & G. 68 Boundary line, a distance of 1046.2 feet to an iron 69 stake at the Northeast corner of the Ada Baskin lot; 70 thence run due South 276 feet to a point of beginning; 71 72 and the Southwest corner of lot now owned by me; thence run East ten chains to a stake; thence run North 73 74 twenty-nine chains to a stake; thence run South 89 75 degrees and 35 minutes West ten chains and ten lengths to a point in Pelicia Creek; thence run South 27 chains 76 to a point of beginning; but the right of way of the C. 77 & G. Railroad Company 100 feet in width, and extending 78 79 across the above lands is hereby expressly reserved and not included. The total acreage of the within tract, 80 81 exclusive of the right of way of the C. & G. Railroad Company is 26.48 acres of land, lying and being in the 82 Southwest quarter of Section 12, Township 19, Range 1 83 East, in Leflore County, Mississippi, and is the same 84 tract of land purchased by me from Robert P. Parish and 85 86 Mrs. Ethel D. Parish, as shown by their warranted deed to me, and recorded in Book 45, Page 556, of the record 87 of Land Deeds of Leflore County, Mississippi, reference 88 to which is hereby made, and which is the same tract of 89 land which is now occupied by the above as a homestead; 90 said lands described as aforesaid, being those lands 91 adjoining a certain tract of land now belonging to 92 93 Leflore County, and used as a poor house for said

96 to additional terms and conditions agreed upon by the Board of
97 Supervisors of Leflore County, Mississippi, and the Mississippi
98 Department of Corrections.

99 **SECTION 3.** In lieu of a transfer and conveyance of the real property and improvements set forth in Section 1 of this act, the 100 101 Delta Correctional Facility Authority, the Mississippi Department of Corrections and Leflore County, Mississippi, are authorized to 102 enter into and/or approve any sublease of that certain real 103 property and any improvements thereon to Leflore County, 104 105 Mississippi, in consideration of the conveyance authorized in 106 Section 2 of this act, or upon such terms and conditions as may be agreed upon by the Department of Corrections, Leflore County, 107 Mississippi, and the Delta Correctional Facility Authority. Any 108 109 sublease authorized under this section may include a purchase option for nominal consideration for Leflore County, Mississippi 110 (or other consideration agreed to by Leflore County, Mississippi), 111 112 which may be exercised under terms and conditions agreed upon by the parties to the sublease. 113

SECTION 4. This act shall take effect and be in force from and after its passage.
