HOUSE BILL NO. 1489

1 AN ACT MAKING A REAPPROPRIATION TO THE DEPARTMENT OF FINANCE
2 AND ADMINISTRATION TO REAUTHORIZE THE EXPENDITURE OF STATE GENERAL
3 FUNDS AND SPECIAL FUNDS PREVIOUSLY APPROPRIATED FOR CONSTRUCTION
4 AND/OR REPAIR AND RENOVATION PROJECTS AT VARIOUS STATE AGENCIES
5 AND INSTITUTIONS, FOR FISCAL YEAR 2004.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

7 **SECTION 1.** The following sum, or so much thereof as may be
8 necessary, is hereby reappropriated out of any money in the State
9 General Fund not otherwise appropriated, to the Department of
10 Finance and Administration, acting through the Bureau of Building,
11 Grounds and Real Property Management, for the purpose of
12 reauthorizing the expenditure of State General Funds, as
13 authorized in Senate Bill No. 3199, Regular Session of 1995,
14 Senate Bill No. 2503, Regular Session of 1996, Senate Bill No.
15 2427, Regular Session of 1997, House Bill No. 1684, Regular
16 Session of 1998, House Bill No. 1331, Regular Session of 1999,
17 House Bill No. 834, Regular Session of 2000, and House Bill No.
18 723, Regular Session of 2001, for the fiscal year beginning July
19 1, 2003, and ending June 30, 2004.....
20 \$ 24,596.00.

21 This reappropriation is made for the purpose of reauthorizing
22 the expenditure of State General Funds for renovating and/or
23 repairing existing state-owned facilities and for purchasing
24 and/or replacing furniture and equipment for all institutions,
25 agencies and departments of the State of Mississippi.

26 Notwithstanding the amount reappropriated under the
27 provisions of this section, in no event shall the amount expended



28 exceed the unexpended balance as of June 30, 2003, or change the
29 purpose for which the funds were originally authorized.

30 **SECTION 2.** The following sum, or so much thereof as may be
31 necessary, is hereby reappropriated out of any money in the State
32 Treasury to the credit of Fund No. 3931, to the Department of
33 Finance and Administration, acting through the Bureau of Building,
34 Grounds and Real Property Management, for the purpose of
35 reauthorizing the expenditure of funds previously appropriated for
36 construction and/or repair and renovation projects at various
37 state agencies and institutions, for the fiscal year beginning
38 July 1, 2003, and ending June 30, 2004.....
39 \$ 36,607,537.00.

40 This reappropriation is made for the purpose of reauthorizing
41 the expenditure of special funds for construction and/or repair
42 and renovation projects at various state agencies and institutions
43 that had been authorized by the Legislature in prior fiscal years.

44 Notwithstanding the amount reappropriated under the
45 provisions of this section, in no event shall the amount expended
46 exceed the unexpended balance as of June 30, 2003, or change the
47 purpose for which the funds were originally authorized.

48 **SECTION 3.** The following sum, or so much thereof as may be
49 necessary, is hereby reappropriated out of any money in the State
50 Treasury to the credit of the Education Enhancement Fund No. 4900,
51 to the Department of Finance and Administration, acting through
52 the Bureau of Building, Grounds and Real Property Management, for
53 the purpose of reauthorizing the expenditure of funds previously
54 appropriated for construction and/or repair and renovation
55 projects at various state agencies and institutions, for the
56 fiscal year beginning July 1, 2003, and ending June 30, 2004
57 \$ 61,109.00.

58 This reappropriation is made for the purpose of reauthorizing
59 the expenditure of special funds for construction and/or repair



60 and renovation projects at various state agencies and institutions
61 that had been authorized by the Legislature in prior fiscal years.

62 Notwithstanding the amount reappropriated under the
63 provisions of this section, in no event shall the amount expended
64 exceed the unexpended balance as of June 30, 2003, or change the
65 purpose for which the funds were originally authorized.

66 **SECTION 4.** The Bureau of Building, Grounds and Real Property
67 Management of the Office of General Services is hereby expressly
68 authorized and empowered to receive, budget and expend any state,
69 local or other source funds designated for supplemental funding of
70 construction and/or repair and renovation projects.

71 **SECTION 5.** The money herein appropriated shall be paid by
72 the State Treasurer out of any money in the State Treasury to the
73 credit of the proper fund or funds as set forth in this act, upon
74 warrants issued by the State Fiscal Officer; and the State Fiscal
75 Officer shall issue his warrants upon requisitions signed by the
76 proper person, officer or officers, in the manner provided by law.

77 **SECTION 6.** This act shall take effect and be in force from
78 and after July 1, 2003.
