HOUSE BILL NO. 1489  
(As Sent to Governor)

1 AN ACT MAKING A REAPPROPRIATION TO THE DEPARTMENT OF FINANCE  
2 AND ADMINISTRATION TO REAUTHORIZE THE EXPENDITURE OF STATE GENERAL  
3 FUNDS AND SPECIAL FUNDS PREVIOUSLY APPROPRIATED FOR CONSTRUCTION  
4 AND/OR REPAIR AND RENOVATION PROJECTS AT VARIOUS STATE AGENCIES  
5 AND INSTITUTIONS, FOR FISCAL YEAR 2004.

6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

7 **SECTION 1.** The following sum, or so much thereof as may be  
8 necessary, is hereby reappropriated out of any money in the State  
9 General Fund not otherwise appropriated, to the Department of  
10 Finance and Administration, acting through the Bureau of Building,  
11 Grounds and Real Property Management, for the purpose of  
12 reauthorizing the expenditure of State General Funds, as  
13 authorized in House Bill No. 1716, Regular Session of 2002, for  
14 the fiscal year beginning July 1, 2003, and ending June 30, 2004.  
15 ..... \$ 24,596.00.

16 This reappropriation is made for the purpose of reauthorizing  
17 the expenditure of State General Funds for renovating and/or  
18 repairing existing state-owned facilities and for purchasing  
19 and/or replacing furniture and equipment for all institutions,  
20 agencies and departments of the State of Mississippi.

21 Notwithstanding the amount reappropriated under the  
22 provisions of this section, in no event shall the amount expended  
23 exceed the unexpended balance as of June 30, 2003, or change the  
24 purpose for which the funds were originally authorized.

25 **SECTION 2.** The following sum, or so much thereof as may be  
26 necessary, is hereby reappropriated out of any money in the State  
27 Treasury to the credit of Fund No. 3931, to the Department of  
28 Finance and Administration, acting through the Bureau of Building,



29 Grounds and Real Property Management, for the purpose of  
30 reauthorizing the expenditure of funds previously appropriated for  
31 construction and/or repair and renovation projects at various  
32 state agencies and institutions, for the fiscal year beginning  
33 July 1, 2003, and ending June 30, 2004.....  
34 ..... \$ 36,607,537.00.

35 This reappropriation is made for the purpose of reauthorizing  
36 the expenditure of special funds for construction and/or repair  
37 and renovation projects at various state agencies and institutions  
38 that had been authorized by the Legislature in prior fiscal years.

39 Notwithstanding the amount reappropriated under the  
40 provisions of this section, in no event shall the amount expended  
41 exceed the unexpended balance as of June 30, 2003, or change the  
42 purpose for which the funds were originally authorized.

43 **SECTION 3.** The following sum, or so much thereof as may be  
44 necessary, is hereby reappropriated out of any money in the State  
45 Treasury to the credit of the Education Enhancement Fund No. 4900,  
46 to the Department of Finance and Administration, acting through  
47 the Bureau of Building, Grounds and Real Property Management, for  
48 the purpose of reauthorizing the expenditure of funds previously  
49 appropriated for construction and/or repair and renovation  
50 projects at various state agencies and institutions, for the  
51 fiscal year beginning July 1, 2003, and ending June 30, 2004  
52 ..... \$ 61,109.00.

53 This reappropriation is made for the purpose of reauthorizing  
54 the expenditure of special funds for construction and/or repair  
55 and renovation projects at various state agencies and institutions  
56 that had been authorized by the Legislature in prior fiscal years.

57 Notwithstanding the amount reappropriated under the  
58 provisions of this section, in no event shall the amount expended  
59 exceed the unexpended balance as of June 30, 2003, or change the  
60 purpose for which the funds were originally authorized.



61           **SECTION 4.** The Bureau of Building, Grounds and Real Property  
62 Management of the Office of General Services is hereby expressly  
63 authorized and empowered to receive, budget and expend any state,  
64 local or other source funds designated for supplemental funding of  
65 construction and/or repair and renovation projects.

66           **SECTION 5.** The money herein appropriated shall be paid by  
67 the State Treasurer out of any money in the State Treasury to the  
68 credit of the proper fund or funds as set forth in this act, upon  
69 warrants issued by the State Fiscal Officer; and the State Fiscal  
70 Officer shall issue his warrants upon requisitions signed by the  
71 proper person, officer or officers, in the manner provided by law.

72           **SECTION 6.** This act shall take effect and be in force from  
73 and after July 1, 2003.
