HOUSE BILL NO. 1509

AN ACT MAKING AN APPROPRIATION FROM SPECIAL FUNDS IN THE 1 STATE TREASURY FOR THE PURPOSE OF DEFRAYING THE EXPENSES OF THE 2 3 STATE BOARD OF AGRICULTURAL AVIATION FOR THE FISCAL YEAR 2004. BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 4 SECTION 1. The following sum, or so much thereof as may be 5 necessary, is hereby appropriated out of any money in the special 6 fund in the State Treasury to the credit of the State Board of 7 Agricultural Aviation, for the purpose of defraying the expenses 8 of the board for the fiscal year beginning July 1, 2003, and 9 ending June 30, 2004..... \$ 98,347.00. 10 SECTION 2. With the funds appropriated under the provisions 11 of Section 1, the following positions are authorized: 12 AUTHORIZED POSITIONS: 13 Permanent: Full Time..... 14 2 15 Part Time..... 0 Time-Limited: Full Time..... 16 0 Part Time..... 17 0 18 With the funds herein appropriated, it is the intention of the Legislature that it shall be the agency's responsibility to 19 20 make certain that funds required to be appropriated for "Personal 21 Services" for Fiscal Year 2005 do not exceed Fiscal Year 2004 22 funds appropriated for that purpose, unless programs or positions are added to the agency's Fiscal Year 2005 budget by the 23 Mississippi Legislature. Based on data provided by the 24 Legislative Budget Office, the State Personnel Board shall 25 26 determine and publish the projected annual cost to fully fund all 27 appropriated positions in compliance with the provisions of this

It shall be the responsibility of the agency head to insure 28 act. 29 that no single personnel action increases this projected annual cost and/or the Fiscal Year 2004 appropriation for "Personal 30 Services" when annualized. If, at the end of any calendar month, 31 32 the State Personnel Board determines that the agency has taken 33 action(s) which would cause the agency to exceed this projected annual cost or the Fiscal Year 2004 "Personal Services" 34 appropriated level, when annualized, then only those actions which 35 reduce the projected annual cost and/or the appropriation 36 requirement will be processed by the State Personnel Board until 37 38 such time as the requirements of this provision are met.

Any transfers or escalations shall be made in accordance withthe terms, conditions and procedures established by law.

No general funds authorized to be expended herein shall be used to replace federal funds and/or other special funds which are being used for salaries authorized under the provisions of this act and which are withdrawn and no longer available.

45 SECTION 3. It is the intention of the Legislature that the 46 State Board of Agricultural Aviation is hereby authorized to 47 accept, budget and expend funds from donations, grants and any 48 special source funds in accordance with rules and regulations of 49 the Department of Finance and Administration in a manner 50 consistent with the escalation of federal funds.

51 SECTION 4. It is the intention of the Legislature that none 52 of the funds appropriated by this act shall be expended for 53 increased charges for State and School Employees' Health Insurance 54 Plan premium rates assessed by the Department of Finance and 55 Administration in excess of the Fiscal Year 2003 premium rates for 56 the health insurance plan.

57 **SECTION 5.** The money herein appropriated shall be paid by 58 the State Treasurer out of any money in the State Treasury to the 59 credit of the proper fund or funds as set forth in this act, upon 60 warrants issued by the State Fiscal Officer; and the State Fiscal

proper person, officer or officers, in the manner provided by law.
SECTION 6. This act shall take effect and be in force from
and after July 1, 2003.
