HOUSE BILL NO. 1529
(As Sent to Governor)

1 AN ACT MAKING AN APPROPRIATION FROM SPECIAL FUNDS IN THE
2 STATE TREASURY FOR THE PURPOSE OF DEFRAYING THE EXPENSES OF THE
3 MISSISSIPPI REAL ESTATE COMMISSION FOR THE FISCAL YEARS 2003 AND
4 2004.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

6 SECTION 1. The following sum, or so much thereof as may be
7 necessary, is hereby appropriated out of any money in the State
8 Treasury to the credit of the Real Estate License Fund, for the
9 purpose of defraying the expenses of the Mississippi Real Estate
10 Commission for the fiscal year beginning July 1, 2003, and ending
11 June 30, 2004..... \$ 914,084.00.

12 SECTION 2. Of the funds appropriated under the provisions of
13 Section 1, not more than the amounts set forth below shall be
14 expended for the respective major objects or purposes of
15 expenditure:

16 MAJOR OBJECTS OF EXPENDITURE:

17 Personal Services:

18 Salaries, Wages and Fringe Benefits.. \$ 539,384.00
19 Travel and Subsistence..... 52,500.00
20 Contractual Services..... 275,000.00

32 With the funds herein appropriated, it is the intention of
33 the Legislature that it shall be the agency's responsibility to
34 make certain that funds required to be appropriated for "Personal
35 Services" for Fiscal Year 2005 do not exceed Fiscal Year 2004
36 funds appropriated for that purpose, unless programs or positions
37 are added to the agency's Fiscal Year 2005 budget by the
38 Mississippi Legislature. Based on data provided by the
39 Legislative Budget Office, the State Personnel Board shall
40 determine and publish the projected annual cost to fully fund all
41 appropriated positions in compliance with the provisions of this
42 act. It shall be the responsibility of the agency head to insure
43 that no single personnel action increases this projected annual
44 cost and/or the Fiscal Year 2004 appropriation for "Personal
45 Services" when annualized. If, at the end of any calendar month,
46 the State Personnel Board determines that the agency has taken
47 action(s) which would cause the agency to exceed this projected
48 annual cost or the Fiscal Year 2004 "Personal Services"
49 appropriated level, when annualized, then only those actions which
50 reduce the projected annual cost and/or the appropriation
51 requirement will be processed by the State Personnel Board until
52 such time as the requirements of this provision are met.

53 Any transfers or escalations shall be made in accordance with
54 the terms, conditions and procedures established by law.

55 No general funds authorized to be expended herein shall be
56 used to replace federal funds and/or other special funds which are
57 being used for salaries authorized under the provisions of this
58 act and which are withdrawn and no longer available.

59 **SECTION 3.** Of the funds provided under the provisions of
60 this act, Twenty-seven Thousand Six Hundred Two Dollars



61 (\$27,602.00) may be used to reallocate or reclassify existing
62 positions of this agency.

63 **SECTION 4.** In addition to all other sums heretofore
64 appropriated, the following sum, or so much thereof as may be
65 necessary, is hereby appropriated out of any money in the State
66 Treasury to the credit of the Real Estate License Fund, for the
67 purpose of defraying the expenses of the Mississippi Real Estate
68 Commission for the fiscal year ending June 30, 2003.....
69 \$ 3,000.00.

70 **SECTION 5.** The money herein appropriated shall be paid by
71 the State Treasurer out of any money in the State Treasury to the
72 credit of the proper fund or funds as set forth in this act, upon
73 warrants issued by the State Fiscal Officer; and the State Fiscal
74 Officer shall issue his warrants upon requisitions signed by the
75 proper person, officer or officers, in the manner provided by law.

76 **SECTION 6.** This act shall take effect and be in force from
77 and after July 1, 2003, except that Section 4 shall take effect
78 and be in force from and after its passage.
