- 7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 8 **SECTION 1.** The board of Commissioners for the North Tunica
- 9 County Fire Protection District is hereby authorized to reimburse
- 10 up to sixty percent (60%) of the tax otherwise levied by the Board
- 11 of Supervisors of Tunica County, Mississippi, and/or Board of
- 12 Commissioners for the North Tunica County Fire Protection District
- 13 pursuant to Section 19-5-189 in consideration for
- 14 owners/developers installing fire protection sprinkler systems in
- 15 new structures being constructed within the territory of the North
- 16 Tunica County Fire Protection District. The North Tunica County
- 17 Fire Protection District is authorized to refund an amount equal
- 18 to sixty percent (60%) of the tax paid levied pursuant to Section
- 19 19-5-189, Mississippi Code of 1972, annually each year for a
- 20 period not to exceed five (5) years. The tax rebate shall be made
- 21 to the property owner and only one (1) rebate shall be made per
- 22 property after the taxes have been paid.
- 23 **SECTION 2.** This act shall take effect and be in force from
- 24 and after its passage.
