HOUSE CONCURRENT RESOLUTION NO. 5

1 A CONCURRENT RESOLUTION PROPOSING AN AMENDMENT TO SECTION 2 170, MISSISSIPPI CONSTITUTION OF 1890, TO REQUIRE EACH MEMBER OF A 3 COUNTY BOARD OF SUPERVISORS ELECTED TO A TERM OF OFFICE BEGINNING 4 ON OR AFTER JANUARY 1, 2008, TO BE A HIGH SCHOOL GRADUATE OR HAVE 5 A GENERAL EQUIVALENCY DIPLOMA (GED) UNLESS HE OR SHE SERVED AS A 6 MEMBER OF A BOARD OF SUPERVISORS BEFORE JANUARY 1, 2008; AND FOR 7 RELATED PURPOSES.

8 BE IT RESOLVED BY THE LEGISLATURE OF THE STATE OF 9 MISSISSIPPI, That the following amendment to the Mississippi 10 Constitution of 1890 is proposed to the qualified electors of the

11 state:

12 Amend Section 170, Mississippi Constitution of 1890, to read 13 as follows:

"Section 170. Each county shall be divided into five 14 15 districts, a resident freeholder of each district shall be selected, in the manner prescribed by law, and the five so chosen 16 shall constitute the board of supervisors of the county, a 17 majority of whom may transact business. Each member of the board 18 of supervisors elected to a term of office beginning on or after 19 January 1, 2008, must be a high school graduate or have a general 20 equivalency diploma (GED) unless he or she served as a member of a 21 board of supervisors before January 1, 2008. The board of 22 23 supervisors shall have full jurisdiction over roads, ferries, and bridges, to be exercised in accordance with such regulations as 24 the Legislature may prescribe, and perform such other duties as 25 may be required by law; provided, however, that the Legislature 26 may have the power to designate certain highways as "state 27 28 highways," and place such highways under the control and supervision of the State Highway Commission, for construction and 29

30 maintenance. The clerk of the chancery court shall be the clerk 31 of the board of supervisors."

32 BE IT FURTHER RESOLVED, That this proposed amendment shall be 33 submitted by the Secretary of State to the qualified electors at 34 an election to be held on the first Tuesday after the first Monday 35 of November 2003, as provided by Section 273 of the Constitution 36 and by general law.

37 BE IT FURTHER RESOLVED, That the explanation of this proposed 38 amendment for the ballot shall read as follows: "This proposed 39 constitutional amendment requires that each member of a county 40 board of supervisors elected to a term of office beginning on or 41 after January 1, 2008, must be a high school graduate or have a 42 general equivalency diploma (GED) unless he or she served as a 43 member of a board of supervisors before January 1, 2008."

BE IT FURTHER RESOLVED, That the Attorney General of the State of Mississippi shall submit this resolution, immediately upon adoption by the Legislature to the Attorney General of the United States or to the United States District Court for the District of Columbia in accordance with the provisions of the Voting Rights Act of 1965, as amended and extended.
