## SENATE BILL NO. 2011

AN ACT TO AMEND SECTIONS 23-15-627 AND 23-15-713, MISSISSIPPI CODE OF 1972, TO ALLOW QUALIFIED ELECTORS TO VOTE BY ABSENTEE BALLOT FOR ANY REASON; TO AMEND SECTION 23-15-653, MISSISSIPPI CODE OF 1972, TO REQUIRE ALL REGISTRARS' OFFICES TO REMAIN OPEN 3 4 FROM 7 A.M. TO 7 P.M. ON THE THREE SATURDAYS PRIOR TO EACH 5 ELECTION; AND FOR RELATED PURPOSES. 6 7 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: SECTION 1. Section 23-15-627, Mississippi Code of 1972, is 8 amended as follows: 9 10 23-15-627. The registrar shall be responsible for furnishing an absentee ballot application form to any elector authorized to 11 receive an absentee ballot. Absentee ballot applications shall be 12 furnished to a person only upon the oral or written request of the 13 elector who seeks to vote by absentee ballot; however, the parent, 14 child, spouse, sibling, legal guardian, those empowered with a 15 power of attorney for that elector's affairs or agent of the 16 elector may orally request an absentee ballot application on 17 behalf of the elector. An absentee ballot application must have 18 the seal of the circuit or municipal clerk affixed to it and be 19 initialed by the registrar or his deputy in order to be utilized 20 to obtain an absentee ballot. A reproduction of an absentee 21 ballot application shall not be valid unless it is a reproduction 22 provided by the office of the registrar of the jurisdiction in 23 which the election is being held and which contains the seal and 24 initials required by this section. 114	SECTION 2. Section 23-15-713, Mississippi Code of 1972, is
115	amended as follows:
116	23-15-713. For the purpose of this subarticle, any duly
117	qualified elector may vote as provided in this subarticle if he be
118	one who falls within the following categories:
119	(a) Any qualified elector who is a bona fide student,
120	teacher or administrator at any college, university, junior
121	college, high, junior high or elementary grade school whose
122	studies or employment at such institution necessitates his absence
123	from the county of his voting residence on the date of any
124	primary, general or special election, or the spouse and dependents
125	of said student, teacher or administrator if such spouse or
126	dependent(s) maintain a common domicile, outside of the county of
127	his voting residence, with such student, teacher or administrator.

- Any qualified elector who is required to be away 128 from his place of residence on any election day due to his 129 employment as an employee of a member of the Mississippi 130 131 congressional delegation and the spouse and dependents of such 132 person if he or she shall be residing with such absentee voter
- away from the county of the spouse's voting residence. Any qualified elector who desires to vote by 134 (C)
- absentee ballot for any reason. 135
- 136 (d) Any person who has a temporary or permanent
- physical disability and who, because of such disability, is unable 137
- 138 to vote in person without substantial hardship to himself or
- others, or whose attendance at the voting place could reasonably 139

- 152 SECTION 3. Section 23-15-653, Mississippi Code of 1972, is
- amended as follows: 153
- 23-15-653. All registrars' offices shall remain open from 7 154
- a.m. until 7 p.m. on the three (3) Saturdays prior to each 155
- 156 election.
- 157 SECTION 4. The Attorney General of the State of Mississippi
- shall submit this act, immediately upon approval by the Governor, 158
- 159 or upon approval by the Legislature subsequent to a veto, to the
- 160 Attorney General of the United States or to the United States

- 161 District Court for the District of Columbia in accordance with the
- 162 provisions of the Voting Rights Act of 1965, as amended and
- 163 extended.
- 164 SECTION 5. This act shall take effect and be in force from
- 165 and after the date it is effectuated under Section 5 of the Voting
- 166 Rights Act of 1965, as amended and extended.
