SENATE BILL NO. 2248

AN ACT TO REQUIRE INSURERS TO FURNISH CERTAIN INFORMATION 1 REGARDING POLICIES OF MOTOR VEHICLE LIABILITY INSURANCE TO THE 2 3 STATE TAX COMMISSION; TO REQUIRE THE STATE TAX COMMISSION TO 4 COMPILE A DATABASE CONTAINING THE NAME OF THE OWNER OF EACH REGISTERED MOTOR VEHICLE, THE MOTOR VEHICLE LICENSE TAG NUMBER OF SUCH VEHICLE, THE VEHICLE IDENTIFICATION NUMBER OF EACH VEHICLE 5 6 AND INDICATING WHETHER THE VEHICLE IS COVERED BY A POLICY OF 7 LIABILITY INSURANCE; TO REQUIRE THE STATE TAX COMMISSION TO MAKE SUCH DATABASE AVAILABLE TO LAW ENFORCEMENT PERSONNEL TO ASSIST IN 8 9 THE ENFORCEMENT OF THE LAW REQUIRING PROOF OF LIABILITY INSURANCE 10 COVERAGE BE MAINTAINED IN MOTOR VEHICLES; TO EXEMPT SUCH DATABASE 11 FROM THE PROVISIONS OF THE MISSISSIPPI PUBLIC RECORDS ACT OF 1983; 12 AND FOR RELATED PURPOSES. 13 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 14 **SECTION 1.** (1) When a policy of motor vehicle liability 15 insurance is purchased in at least the minimum amounts required by 16 Section 63-15-3(j), the insurer shall provide the following 17 18 information to the State Tax Commission: (a) The name and address of the named insured; 19 The identification number of the vehicle covered 20 (b) afforded by the policy; 21 (c) The limits of liability; and 22 The policy period. 23 (d) When a policy of motor vehicle liability insurance with 24 (2) at least the minimum amounts required by Section 63-15-3(j) is 25 26 cancelled or terminated, for whatever reason, the insurer shall 27 provide the following information to the State Tax Commission: (a) The name and address of the named insured; 28 The identification number of the vehicle covered (b) 29 afforded by the policy; 30 31 (C) The limits of liability; and 32 (d) The policy period.

(1) Utilizing the information that is required 33 SECTION 2. to be furnished pursuant to Section 1 of this act and information 34 regarding motor vehicle registrations that is available to the 35 State Tax Commission from county tax collectors, the State Tax 36 37 Commission shall compile a database that shows the owner of each registered vehicle, the license tag number of such vehicle, the 38 identification number of such vehicle and indicates whether the 39 vehicle is covered by a policy of motor vehicle liability 40 insurance in at least the minimum amounts required by Section 41 42 63-15-3(j).

43 (2) The State Tax Commission shall update the database44 periodically.

(3) The State Tax Commission shall make the database
required to be compiled pursuant to subsection (1) of this section
available to law enforcement personnel to assist in the
enforcement of Section 63-15-4.

49 (4) The database compiled by the State Tax Commission
50 pursuant to this section shall be exempt from the provisions of
51 the Mississippi Public Records Act of 1983.

52 **SECTION 3.** This act shall take effect and be in force from 53 and after July 1, 2003.
