SENATE BILL NO. 2277

AN ACT TO AMEND SECTION 25-11-107, MISSISSIPPI CODE OF 1972, 1 TO AUTHORIZE THE BOARD OF TRUSTEES OF THE PUBLIC EMPLOYEES' 2 3 RETIREMENT SYSTEM TO INCLUDE AS A COVERAGE GROUP MEMBERS OF THE 4 MISSISSIPPI NATIONAL GUARD WHO ARE COMPENSATED FOR TRAINING AND MILITARY DUTY OUT OF FEDERAL FUNDS APPROPRIATED FOR USE BY THE 5 MISSISSIPPI NATIONAL GUARD PROVIDED FUNDS ARE MADE AVAILABLE TO 6 PAY EMPLOYER CONTRIBUTIONS ON THE SALARIES OF SUCH MEMBERS FROM 7 THE FEDERAL GOVERNMENT OR STATE APPROPRIATIONS; AND FOR RELATED 8 9 PURPOSES.

10 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 11 SECTION 1. Section 25-11-107, Mississippi Code of 1972, is 12 amended as follows:

25-11-107. (1) The Board of Trustees of the Public 13 Employees' Retirement System is hereby authorized and empowered to 14 include as a coverage group under this article those regular 15 16 full-time civilian employees of the Mississippi National Guard whose entire salary is paid on certification out of allotted 17 federal funds, provided funds are made available from the federal 18 government or state appropriations to pay employers' contributions 19 on the salaries of such employees. In the event the employers' 20 contributions on such salaries should fail to be paid in full to 21 the Public Employees' Retirement System, the Board of Trustees of 22 23 the Public Employees' Retirement System shall be prevented from 24 allowing service credit for any such period of delinquency and such retirants would be allowed only such service credits as had 25 accrued up to the time of any such delinquency; but members who 26 remain in the system with their service credits suspended during 27 any such period of delinquency may obtain full service credit upon 28 29 the payment of all employers' contributions due the retirement 30 system for the entire coverage group.

The Board of Trustees of the Public Employees' 31 (2) Retirement System is hereby authorized and empowered to include as 32 a coverage group under this article those members of the 33 Mississippi National Guard who are compensated for field training, 34 35 armory drills, training assemblies or other military training or military duty and whose compensation for such training and duty is 36 paid out of federal funds appropriated for the use of the 37 Mississippi National Guard, provided funds are made available from 38 the federal government or state appropriations to pay employers' 39 contributions on the salaries of such members. In the event the 40 employers' contributions on such salaries should fail to be paid 41 in full to the Public Employees' Retirement System, the Board of 42 43 Trustees of the Public Employees' Retirement System shall be prevented from allowing service credit for any such period of 44 delinquency and such retirants would be allowed only such service 45 credits as had accrued up to the time of any such delinquency; but 46 members who remain in the system with their service credits 47 suspended during any such period of delinquency may obtain full 48 service credit upon the payment of all employers' contributions 49 50 due the retirement system for the entire coverage group. SECTION 2. This act shall take effect and be in force from 51 52 and after July 1, 2003.
