SENATE BILL NO. 2328

AN ACT TO AMEND SECTION 19-3-81, MISSISSIPPI CODE OF 1972, TO AUTHORIZE SHERIFFS TO EXPEND MONIES IN THE INMATE CANTEEN FUND FOR ANY EDUCATIONAL RELATED EXPENSES; AND FOR RELATED PURPOSES.

- 4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 5 **SECTION 1.** Section 19-3-81, Mississippi Code of 1972, is
- 6 amended as follows:
- 7 19-3-81. (1) (a) The board of supervisors of any county is
- 8 hereby authorized and empowered, in its discretion, to allow the
- 9 sheriff of such county to operate a facility or facilities to be
- 10 known as an inmate canteen facility or facilities, the purpose of
- 11 which is to make available certain goods and other items of value
- 12 for purchase by inmates confined in the county jail of such
- 13 county, employees of the county jail and persons visiting inmates
- 14 or employees. The sheriff of such county shall promulgate rules
- 15 and regulations for the operation of such a facility.
- 16 (b) If the board of supervisors of any county
- 17 authorizes the sheriff of such county to operate such a facility
- 18 or facilities as provided in subsection (1) of this section, any
- 19 funds which may be derived from the operation of an inmate canteen
- 20 facility or facilities shall be deposited into a special fund in
- 21 the county treasury to be designated as the "Inmate Canteen Fund."
- 22 Any monies in the special fund may be expended solely by the
- 23 sheriff of the county for any educational related expenses, to
- 24 purchase equipment and supplies and to provide for maintenance of
- 25 the equipment purchased for the benefit and welfare of the inmates
- 26 incarcerated in the county jail. The term "supplies" shall not
- 27 include supplies related to the personal hygiene of inmates.

28	(2) In lieu of the authority to operate an inmate canteen
29	facility under subsection (1) of this section, the board of
3 0	supervisors of any county, in its discretion, may authorize the
31	sheriff to contract with a private company for the provision of
32	commissary services to inmates of the county jail. Money
33	collected from or on behalf of an inmate for the purchase of
34	commissary items shall be deposited to the credit of the inmate
35	into a special fund in the county treasury to be designated as the
36	"Inmate Commissary Trust Fund." Money in the special fund may be
37	expended upon requisition by the sheriff for the purchase and
38	delivery of prepackaged items from the company with which the
39	sheriff has contracted. The sheriff shall adopt rules and
40	regulations for the letting of contracts for commissary services,
41	the collection and distribution of commissary items to inmates,
12	and the items that inmates may purchase through commissary
43	services contracts.
