- 8 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 9 **SECTION 1.** (1) That portion of Mississippi Highway 315
- 10 beginning at the eastern boundary of the corporate limits of the
- 11 City of Water Valley, Yalobusha County, and extending easterly to
- 12 its intersection with Mississippi Highway 9W in Lafayette County
- is designated and shall be known as the "Dr. Dewitt Clinton French
- 14 Memorial Highway."
- 15 (2) The Mississippi Department of Transportation shall erect
- 16 and maintain appropriate signs along and approaching the segment
- 17 of highway described in subsection (1) of this section.
- 18 **SECTION 2.** (1) That portion of Mississippi Highway 1
- 19 beginning at the Issaquena/Washington County line, and extending
- 20 southerly to its intersection with U.S. Highway 61 in Sharkey
- 21 County is designated and shall be known as the "C.B. 'Buddie'
- 22 Newman Memorial Highway."
- 23 (2) The Mississippi Department of Transportation shall erect
- 24 and maintain appropriate signs along and approaching the segment
- of highway described in subsection (1) of this section.
- 26 **SECTION 3.** (1) That portion of Mississippi Highway 25 North
- 27 that contains the turn lane for traffic to Yellow Creek Port in
- 28 Tishomingo County is designated and shall be known as "Martha
- 29 Segars Road."

- 30 The Mississippi Department of Transportation shall erect
- and maintain appropriate signs along and approaching the segment 31
- of highway described in subsection (1) of this section. 32
- SECTION $\underline{4}$. This act shall take effect and be in force from 33
- and after its passage. 34
