SENATE BILL NO. 2514

1 AN ACT TO AMEND SECTION 49-19-3, MISSISSIPPI CODE OF 1972, TO  
2 REMOVE THE REPEALER ON THE AUTHORITY OF THE FORESTRY COMMISSION TO  
3 HIRE LAW ENFORCEMENT PERSONNEL; AND FOR RELATED PURPOSES.

4 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

5 **SECTION 1.** Section 49-19-3, Mississippi Code of 1972, is  
6 amended as follows:

7 49-19-3. The duties and powers of the commission shall be:

8 (1) To appoint a state forester, who shall serve at the will  
9 and pleasure of the commission and who is qualified to perform the  
10 duties as set forth herein; and to pay him such salary as is  
11 provided by the Legislature, and allow him such office expenses  
12 incidental to the performance of his official duties as the  
13 commission, in its discretion, may deem necessary; and to charge  
14 him with the immediate direction and control, subject to the  
15 supervision and approval of the commission, of all matters  
16 relating to forestry as authorized herein. Any person appointed  
17 by the commission as state forester shall have received a  
18 bachelor's degree in forestry from an accredited school or college  
19 of forestry and shall be licensed and registered under the  
20 provisions of the Mississippi Foresters Registration Law (Section  
21 73-36-1 et seq.) and in addition shall have had at least five (5)  
22 years' administrative experience in a forestry-related field.

23 (2) To take such action and provide and maintain such  
24 organized means as may seem necessary and expedient to prevent,  
25 control and extinguish forest fires, including the enforcement of  
26 any and all laws pertaining to the protection of forests and  
27 woodland.



28           (3) To encourage forest and tree planting for the production  
29 of a wood crop, for the protection of water supply, for windbreak  
30 and shade, or for any other beneficial purposes contributing to  
31 the general welfare, public hygiene and comfort of the people.

32           (4) To cause to be made such technical investigations and  
33 studies concerning forest conditions, the propagation, care and  
34 protection of forest and shade trees, the care and management of  
35 forests, their growth, yield and the products and by-products  
36 thereof, and any other competent subject, including forest  
37 taxation, bearing on the timber supply and needs of the state,  
38 which the commission, in its discretion, may deem proper.

39           (5) To assist and cooperate with any federal or state  
40 department or institution, county, town, corporation or  
41 individual, under such terms as in the judgment of the commission  
42 will best serve the public interest, in the preparation and  
43 execution of plans for the protection, management, replacement, or  
44 extension of the forest, woodland and roadside or other ornamental  
45 tree growth in the state.

46           (6) To encourage public interest in forestry by means of  
47 correspondence, the public press, periodicals, the publication of  
48 bulletins and leaflets for general distribution, the delivery of  
49 lectures in the schools and other suitable means, and to cooperate  
50 to the fullest extent with the extension department services of  
51 the state colleges in promoting reforestation. It shall be the  
52 duty of the state forester to cooperate with private timber owners  
53 in laying plans for the protection, management and replacement of  
54 forests and in aiding them to form protection associations. It  
55 shall be his duty to examine all timbered lands belonging to the  
56 state and its institutions and report to the commission upon their  
57 timber conditions and actual value, and also whether some of these  
58 lands may not be held as state forests. He shall be responsible  
59 for the protection and management of lands donated, purchased or



60 belonging to the state or state institutions, and all other lands  
61 reserved by the state as state forests.

62 (7) To control the expenditure of any and all funds  
63 appropriated or otherwise made available for the several purposes  
64 set forth herein under suitable regulations and restrictions by  
65 the commission and to specifically authorize any officer or  
66 employee of the commission to incur necessary and stipulated  
67 expenses in connection with the work in which such person may be  
68 engaged.

69 (8) To submit annually to the Legislature a report of the  
70 expenditures, proceedings and results achieved, together with such  
71 other matters including recommendations concerning legislation as  
72 are germane to the aims and purposes of this chapter.

73 (9) To create, establish and organize the State of  
74 Mississippi into forestry districts for the most effective and  
75 efficient administration of the commission.

76 (10) To appoint, upon the state forester's recommendation,  
77 six (6) individuals who shall be designated Mississippi Forestry  
78 Commission Law Enforcement Officers with authority to bear arms,  
79 investigate and make arrests; however, the law enforcement duties  
80 and authority of the officers shall be limited to woods arson.  
81 The officers shall comply with applicable minimum educational and  
82 training standards for law enforcement officers. \* \* \*

83 **SECTION 2.** This act shall take effect and be in force from  
84 and after its passage.
