| 6 | SECTION 1. Section 23-15-191, Mississippi Code of 1972, is |
| 7 | amended as follows: |
| 8 | 23-15-191. The first primary shall be held on the first |
| 9 | Tuesday after the first Monday of <u>September</u> preceding any regular |
| 10 | or general election; and the second primary shall be held three |
| 11 | (3) weeks thereafter. Any candidate who receives the highest |
| 12 | popular vote cast for the office which he seeks in the first |
| 13 | primary shall thereby become the nominee of the party for such |
| 14 | office; provided also it be a majority of all the votes cast for |
| 15 | that office. If no candidate receive such majority of popular |
| 16 | votes in the first primary, then the two (2) candidates who |
| 17 | receive the highest popular vote for such office shall have their |
| 18 | names submitted as such candidates to a second primary, and the |
| 19 | candidate who leads in such second primary shall be nominated to |
| 20 | the office. When there is a tie in the first primary of those |
| 21 | receiving next highest vote, these two (2) and the one (1) |
