SENATE BILL NO. 2661

1 AN ACT TO AMEND SECTION 83-41-211, MISSISSIPPI CODE OF 1972, 2 TO REQUIRE THAT CERTAIN INSURANCE POLICES OR PLANS PROVIDE 3 REIMBURSEMENT FOR SERVICES RENDERED BY MARRIAGE AND FAMILY 4 THERAPISTS; AND FOR RELATED PURPOSES.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 6 **SECTION 1.** Section 83-41-211, Mississippi Code of 1972, is 7 amended as follows:

8 83-41-211. Whenever any policy of insurance or any medical 9 service plan or hospital service contract or hospital and medical 10 service contract issued in this state provides for reimbursement for any diagnosis and treatment of mental, nervous or emotional 11 disorders only which are within the lawful scope of practice of a 12 duly licensed psychologist as defined in Section 73-31-3, within 13 the lawful scope of practice of a duly licensed professional 14 counselor as defined in Section 73-30-3, or within the lawful 15 scope of practice of a duly licensed clinical social worker as 16 defined in Section 73-53-3, or within the lawful scope of practice 17 of a duly licensed marriage and family therapist as defined in 18 Section 73-54-5, the insured or other person entitled to benefits 19 under such policy shall be entitled to reimbursement for such 20 services, whether such services are performed by a duly licensed 21 physician or by a duly licensed psychologist, by a duly licensed 22 professional counselor or by a duly licensed clinical social 23 worker, or by a duly licensed marriage and family therapist, 24 notwithstanding any provision to the contrary in any statute or in 25 26 such policy, plan or contract. Duly licensed psychologists shall be entitled to participate in such policies, plans or contracts 27 providing for the diagnosis and treatment of mental, nervous or 28 S. B. emotional disorders only as authorized by Section 73-31-3. 29 A duly licensed professional counselor shall be entitled to participate 30 in such policies, plans or contracts providing for the diagnosis 31 32 and treatment of mental, nervous or emotional disorders only as 33 authorized by Section 73-30-3. A duly licensed clinical social worker shall be entitled to participate in such policies, plans or 34 contracts providing for the diagnosis and treatment of mental, 35 nervous or emotional disorders only as authorized by Section 36 73-53-3. A duly licensed marriage and family therapist shall be 37 entitled to participate in such policies, plans or contracts 38 providing for the diagnosis and treatment of mental, nervous or 39 emotional disorders only as authorized by Section 73-54-5 et seq. 40 This act shall take effect and be in force from 41 SECTION 2. and after July 1, 2003. 42
