SECTION 8. It is the intention of the Legislature that, from the funds provided herein to the State Board of Education, not less than Twenty-one Million Dollars (\$21,000.000.00) shall be expended for textbooks as defined in Section 37-43-1, Mississippi Code of 1972. The State Department of Education shall report to the Legislature the amount of expenditures for each school district no later than October 31, 2004.

SECTION 9. The State Department of Education shall prepare and present to the Joint Legislative Budget Committee and the Department of Finance and Administration and make available to the Legislature an accounting of program expenditures for all programs once at the beginning of the legislative session and once at the end of the fiscal year. The department at the same time shall present a summary report for each program.

210 SECTION 10. No school district shall expend any funds received under the School Ad Valorem Reduction Grant, unless such 211 212 school district has specifically identified the amount of said grant within the published budget as required by Section 37-61-9, 213 214 Mississippi Code of 1972. The published budget shall include the 215 following statement: "Ad Valorem taxes will be \$_____ less as a result of the Ad Valorem Reduction Grants enacted by the 216 217 Mississippi Legislature in 1992."

SECTION 11. Of the State General Funds provided herein to 218 the State Department of Education, excluding the Vocational and 219 Technical Education Division, for the purpose of providing 220 financial assistance for the education of exceptional children as 221 222 determined under Section 37-23-63, Mississippi Code of 1972, children who are certified by the designated authority as 223 224 requiring inpatient care in a private intermediate care facility for the mentally retarded or psychiatric residential treatment 225

facility, with Medicaid reimbursement, shall be eligible and 226 entitled to receive state financial assistance under the 227 provisions of Section 37-23-69, Mississippi Code of 1972, in an 228 229 amount not to exceed Five Thousand Dollars (\$5,000.00) from state 230 funds, per child per school year, if an approved private school is operated as an integral part of the facility which provides 231 twenty-four (24) hours a day monitoring, treatment and education, 232 except that the State Department of Education is authorized to 233 pilot a fee-for-service based cost system for children served 234 through Millcreek Schools, Inc. 235

236 SECTION 12. The State Department of Education shall transfer the designated amounts to the appropriate entities, which shall 237 238 assume full responsibility for the expenditure of these funds in accordance with state laws and accept all responsibility for any 239 improper expenditure, which shall include the following: 240 National Guard Youth Challenge Program, World Class Teacher 241 Programs, USM Special Education Program, Soil and Water 242 243 Conservation Commission, Mississippi School Boards Association, Mississippi Eye Screening Program - Vision Research Corp, Very 244 245 Special Arts, Arts Institute, Jackson State University Media Center, Jobs for Mississippi Graduates, Mississippi Symphony, 246 247 University of Southern Mississippi Safe Schools Program, Mississippi State University Center for Education Design, Writing 248 and Thinking Institute and Greater Columbus Early Learning Center. 249 250 SECTION 13. It is the intention of the Legislature that the State Department of Education shall have the authority to accept, 251 252 budget and expend any source funds not to exceed Thirty Million Dollars (\$30,000,000.00), that become available to the department 253 to carry out the provisions of those funds in a manner consistent 254 255 with the rules and regulations of the Department of Finance and 256 Administration.

257 **SECTION 14.** Of the funds provided herein for the purpose of 258 funding the Mississippi Adequate Education Program as determined

under Section 37-151-7, Mississippi Code of 1972, the base student cost in Fiscal Year 2004 shall be Three Thousand Six Hundred Twenty-nine Dollars (\$3,629.00).

SECTION 15. With the funds provided herein to the Mississippi Schools for the Blind and Deaf, it is the intention of the Legislature that the academic teachers at the Mississippi School for the Deaf and the Mississippi School for the Blind shall receive their annual increment.

SECTION 16. 267 It is the intention of the Legislature that none of the funds herein provided to the Mississippi Schools for the 268 269 Blind and Deaf shall be expended to hire any person on a contractual basis, for any period for any purpose, without the 270 271 express prior approval of the State Personnel Director. The State Personnel Director shall consider, in approving such contracts, 272 the availability of funds, the need for services, compliance with 273 274 the State Compensation Plan and the qualifications of the persons offering to perform the services. Further, the State Fiscal 275 276 Officer shall not pay any warrant that is in violation of this 277 section.

278 SECTION 17. Of the funds provided herein to pay annual compensation to the Chickasaw Cession counties, the sum of 279 280 Sixty-two Thousand One Hundred Ninety-one Dollars (\$62,191.00), which is the aggregate sum that the school districts 281 in the Chickasaw Cession receive annually from interest payments 282 283 from the Chickasaw School Fund under Section 212, Mississippi Constitution of 1890, shall be deducted from the allocations to 284 285 the school districts as provided in Section 29-3-137, Mississippi Code of 1972, and shall be distributed among the school districts 286 287 in the Chickasaw Cession by the State Department of Education in the manner that such interest payments were distributed during 288 Fiscal Year 1985. 289

290 **SECTION 18**. The following sum, or so much thereof as may be 291 necessary, is hereby appropriated out of any money in the State

General Fund not otherwise appropriated, to the Mississippi 292 Authority for Educational Television for the purpose of defraying 293 the expenses of said Authority, for the fiscal year beginning 294 295 July 1, 2003, and ending June 30, 2004\$ 5,647,017.00. 296 SECTION 19. 328 SECTION 21. With the funds appropriated herein to the 329 Mississippi Authority for Educational Television, funds shall 330 first be used for the continuation of a full and complete 331 broadcast schedule of educational and instructional, professional 332 growth, and public service programs, with the production of new 333 films and programs to be secondary thereto.

SECTION 22. It is the intention of the Legislature that no 334 335 part of the funds provided herein to the Mississippi Authority for Educational Television shall be transferred to, expended by, or 336 used, directly or indirectly, for the benefit of any public 337 relations, publicity or publication activities of any other state 338 agency, department or officer, nor shall any personnel paid or 339 equipment purchased with funds appropriated hereby be transferred 340 or assigned to any other state agency, department or officer for 341 342 public relations, publicity or publication activities of such 343 office.

344 SECTION 23. It is the intention of the Legislature that the 345 Mississippi Authority for Educational Television shall have the 346 authority to expend funds in the Capital Equipment Replacement 347 Revolving Fund, in accordance with Section 37-63-17, Mississippi 348 Code of 1972, for the purpose of purchasing technical equipment 349 for operating the educational radio and television facilities.

350 SECTION 24. It is the intention of the Legislature that the 351 Mississippi Authority for Educational Television shall have the 352 authority to escalate, budget and expend funds from any source not 353 to exceed Two Million Dollars (\$2,000,000.00) in accordance with 354 rules and regulations of the Department of Finance and 355 Administration in a manner consistent with the escalation of 356 federal funds.

All industrial training program commitments made in 500 Fiscal Year 2004 and future fiscal years shall be based only upon funds available in this section and any proposed commitments shall 501 502 be approved by the Executive Director of the State Board for Community and Junior Colleges, or the Executive Director's 503 designee prior to such commitment being finalized. 504 Industrial training program commitments shall be made and based only upon 505 506 training services provided and not for a specific funding amount. 507 Any expenditures of funds authorized in this section are limited 508 to obligations made July 1, 2003, or after, and shall not be 509 expended for obligations made prior to this date.

510 SECTION 36. The funds appropriated under the provisions of 511 this act and allocated for the purpose of hiring nursing and 512 allied health teachers, awarding interest free nursing and allied 513 health student loans, and providing instructional support for the 514 Rural Health Corps shall be allocated as follows:

515 (1) One-half (1/2) divided equally among the fifteen (15)516 public community and junior colleges.

517 (2) One-half (1/2) divided upon the basis of the number of 518 full-time academic, technical and vocational public community and 519 junior college students actually enrolled and in attendance on the 520 last day of the sixth week of the fall semester or its equivalent

521 of the preceding year counting only those students who reside 522 within the State of Mississippi.

523 The public community and junior colleges shall prepare and 524 make available to the Legislature and the Legislative Budget 525 Office an accounting of expenditures and program accomplishments 526 of the Rural Health Corps Program for each of the individual 527 community and junior colleges in a format and manner prescribed by 528 the Legislative Budget Office.

529 SECTION 37. The funds appropriated under the provisions of 530 this act and allocated for funding life and health insurance for 531 all employees of the public community and junior colleges shall 532 only be used to participate in the State and School Employees' 533 Life and Health Insurance Plan, and any of these funds which are 534 not expended during the fiscal year shall be carried forward for 535 the same purposes during the next succeeding fiscal year.

536 **SECTION 38.** A Mississippi Prepaid Affordable College Tuition 537 (MPACT) program beneficiary shall be considered a Mississippi 538 resident for the purposes of participating in funds appropriated 539 herein to the State Board for Community and Junior Colleges 540 regardless of the beneficiary's residence on the date of 541 enrollment, as set out in Mississippi Code Annotated, Section 542 37-155-5(d)(iii).

543 SECTION 39. It is the intention of the Legislature that the 544 State Board of Community and Junior Colleges is hereby authorized 545 to accept, budget and expend funds from any source in an amount 546 not to exceed Five Hundred Thousand Dollars (\$500,000.00) in 547 accordance with rules and regulations of the Department of Finance 548 and Administration in a manner consistent with the escalation of 549 federal funds.

550 **SECTION 40**. The funds appropriated in this act for the aid 551 and support of the public and community junior colleges shall be 552 apportioned in accordance with the followed assigned weights:

562 Such Academic, Technical, and Vocational funds shall be disbursed to such public community and junior colleges on the 563 basis of the full-time enrollment of each such public community 564 and junior college as of the last day of the sixth week of the 565 fall semester or its equivalent of the preceding year, counting 566 567 only students who reside within the State of Mississippi. Part-time academic vocational and technical credit courses may 568 qualify on the basis of the prior year full-time equivalency of 569 part-time and summer students, counting only students who reside 570 571 within the State of Mississippi.

572 Virtual Community College hosted and provided courses may 573 qualify on the basis of the prior year full-time equivalency of 574 virtual community college hours generated during the summer, fall 575 and spring semesters that did not make a student full-time in the 576 fall semester.

577 The Director of the State Board for Community and Junior 578 Colleges, or his designee, shall audit each public community and 579 junior college and shall determine who shall be counted in each 580 college and shall certify the number to the State Board for 581 Community and Junior Colleges.

If, pending determination of the enrollment of students at the public community and junior colleges entitled to participate in this appropriation, as provided for in this subsection, the State Board for Community and Junior Colleges shall find and determine that any such public or community junior college does

not have sufficient funds on hand for payment of the necessary 587 expenses of its operation for the period commencing July 1, 2003, 588 until distribution of the funds appropriated hereby, then, in that 589 590 event, the State Board for Community and Junior Colleges is 591 expressly authorized to make an advance to any such public community or junior college or colleges not having sufficient 592 operating funds for such period from the funds appropriated 593 hereby; provided, however, that the amount of any such advance to 594 595 any one public community or junior college shall not exceed thirty-three percent (33%) of the amount of state appropriated 596 597 funds received by such public community or junior college during the preceding fiscal year; and provided, further, that the amount 598 599 of any such advance shall be deducted from the pro rata part of 600 the funds appropriated hereby accruing to said public community or junior college when enrollment has been ascertained and 601 distribution of funds is made. 602

603 SECTION 41. No part of the amount herein appropriated for 604 the aid and support of public community and junior colleges shall 605 be used by the State Board for Community and Junior Colleges for 606 administrative or other purposes except in the manner and to the 607 extent authorized in the act making an appropriation for the 608 expenses of the State Board for Community and Junior Colleges.

609 **SECTION 42.** The following public community and junior 610 colleges which qualify shall participate in the funds provided in 611 this act for the aid and support of public community and junior 612 colleges:

SECTION 48. It is the intention of the Legislature that upon the Ayers Settlement Agreement becoming final and effective according to its terms (including, but not limited to, the exhaustion of all rights to appeal), funds necessary to comply with the Ayers Settlement Agreement shall be appropriated in the next Legislative Session.

809 SECTION 49. It is the intent of the Legislature that the Board of Trustees of State Institutions of Higher Learning shall 810 811 allocate funds to the off-campus centers based on a minimum rate of sixty-five percent (65%) of the on-campus cost of a full-time 812 equivalent student. The on-campus distribution is to be 813 814 determined without regard to the costs incurred by any one or more of them in the operation of off-campus degree completing centers' 815 816 classes. Of the funds provided herein for support of the 873 Gulf Coast Research Laboratory, the Board of Trustees of State 874 875 Institutions of Higher Learning shall allocate for Sea Grants matching One Hundred Seventy-five Thousand Dollars (\$175,000.00) 876 for the Fiscal Year 2004. 877 878 Provided further, it is the intention of the Legislature, in the event budget reductions are imposed on the Gulf Coast Research 879 880 Laboratory by the Board of Trustees of State Institutions of Higher Learning, as a result of the Governor ordering budget 881 882 reductions under the provisions of Section 27-104-13 or 31-17-123, 883 Mississippi Code of 1972, the same percent reduction will be S. After all such delinquent charges have been 893 894 paid by a client, the laboratory may provide additional services to the client. 895

SECTION 55. It is the intention of the Legislature that the Board of Trustees of State Institutions of Higher Learning shall ensure that none of the funds apportioned in this act for the Out-of-State Educational Program shall be paid to or for the benefit of any student who enters a school outside the State of Mississippi for the first time, subsequent to July 1, 1982, in any discipline in the fields of medicine or dentistry.

903 SECTION 56. It is the intention of the Legislature that of 904 the State General Funds provided herein for financial aid programs authorized by law, the Board of Trustees of the State Institutions 905 906 of Higher Learning shall expend from the support of the out-of-state graduate and professional studies program an amount 907 908 not exceeding the funding necessary, contingent upon the availability of qualified applicants, for ten (10) new entering 909 910 optometry students and the number of returning optometry students who received funding under the program during the preceding school 911 year; for ten (10) new entering chiropractic students, with not 912 913 more than twenty-five (25) chiropractic students overall; and seven (7) new entering osteopathic medical students and the number 914 915 of returning osteopathic medical students who received funding

918 **SECTION 57.** In the allocation of funds provided herein to 919 the Board of Trustees of State Institutions of Higher Learning for 920 financial aid programs authorized by law, it is the intention of 921 the Legislature that priority shall be given and funds shall be 922 first allocated to all students eligible for financial aid under 923 the provisions of Sections 37-107-1 through 37-107-7 and Sections 924 37-108-1 through 37-108-5, Mississippi Code of 1972.

SECTION 58. It is the intention of the Legislature that all 925 926 funds provided herein to the Board of Trustees of State Institutions of Higher Learning for financial aid programs 927 authorized by law shall be accounted for in a detailed statement 928 showing when, to whom, and for what purpose applied, and this 929 statement shall be submitted at the next regular session of the 930 Legislature within ten (10) days after the convening thereof. A 931 report of loans made and receipt of repayment of loans to the fund 932 933 shall be reported. The amount of repayment that is in arrears shall also be included. Such report shall include the number of 934 students at each institution receiving financial assistance and 935 the amount of such assistance, and an estimate of the financial 936 937 requirement of the various loan programs for the next year. No public or private institution of higher learning receiving funds 938 under the respective provisions of this act, for the purpose of 939 940 issuing scholarship grants or loans, shall issue any official transcripts for any persons who have any amount of repayment in 941 942 arrears on that date such official transcript is requested.

943 Furthermore, all such funds received and expended shall be 944 reported and otherwise accounted for in accordance with the 945 provisions of Section 37-143-21, Mississippi Code of 1972.

946 **SECTION 59.** It is the intention of the Legislature that all 947 fees charged and collected by the University Research Center for 948 services provided by the Mississippi Automated Resource

949 Information System (MARIS) shall be deposited in a special fund to 950 be known as the "Mississippi Automated Resource Information System 951 (MARIS) Revolving Fund." All monies in the revolving fund shall 952 be used by MARIS exclusively for the support of MARIS projects and 953 activities.

With the funds provided herein for the support 954 SECTION 60. of the University of Mississippi Medical Center, the following 955 shall be maintained: the School of Medicine, the School of 956 Dentistry, the School of Nursing, the School of Health Related 957 Professions, the Teaching Hospital and the Medical Center Service 958 959 The University of Mississippi Medical Center shall prepare Area. and make available to the Legislature an accounting of 960 expenditures for each of the divisions listed in this section at 961 the beginning of the legislative session. 962

963 **SECTION 61.** Due to critical nurse shortages and staffing, it 964 is the intent of the Legislature to enhance recognition of 965 excellence and expand the experience factor in attracting 966 gualified registered nurses.

967 SECTION 62. Of the funds provided herein for the University 968 of Mississippi Medical Center, none may be used to provide medical services on behalf of any state agency, institution or political 969 970 subdivision, except to the extent that such agency, institution or political subdivision reimburses the hospital for the cost of the 971 services provided. Upon the rendering of medical services to any 972 973 such agency, institution or political subdivision, the hospital shall issue an invoice for the charges which shall be paid within 974 975 ninety (90) days. In the event that payment is not made within ninety (90) days, the hospital shall discontinue providing 976 services to that agency, institution, or political subdivision 977 until all outstanding charges have been paid. 978

979 **SECTION 63.** With the funds provided herein to the 980 Mississippi Cooperative Extension Service, it is the intention of 981 the Legislature that the Mississippi Cooperative Extension Service

982 provide programs in the emphasis areas of Agriculture, Home983 Economics, 4-H, and Community Resource Development in each county.

984 **SECTION 64.** It is the intention of the Legislature that of 985 the funds provided herein for the Alcorn State University 986 Agricultural Programs, none shall be used for the purpose of 987 defraying the expenses of the Agribusiness Council.

988 SECTION 65. It is the intention of the Legislature that of 989 the funds provided herein for the Alcorn State University 990 Agricultural Programs, an amount of Two Hundred Thousand Dollars 991 (\$200,000.00) shall be used for the Mississippi Natural Products 992 Association, Incorporated.

993 **SECTION 66.** It is the intention of the Legislature that the 994 Board of Trustees of State Institutions of Higher Learning shall 995 first use special funds to the greatest extent possible to defray 996 the costs of providing remediation at the state-supported 997 institutions of higher learning.

SECTION 67. It is the intention of the Legislature that none 998 999 of the funds provided herein to the Board of Trustees of State 1000 Institutions of Higher Learning shall be expended for any purpose 1001 that is not actually required or necessary for performing any of the powers or duties of the Board of Trustees of State 1002 1003 Institutions of Higher Learning, or any of the powers or duties of any institution under the jurisdiction of the board of trustees, 1004 that are authorized by the Mississippi Constitution of 1890, state 1005 1006 or federal law, or rules or regulations that implement state or 1007 federal law.

SECTION 68. The Board of Trustees of State Institutions of Higher Learning shall submit to the Committee on Appropriations of both houses of the Mississippi Legislature by January 1, 2004, a consolidated report for all the several institutions under its jurisdiction, on forms and in a manner to be prescribed by the Legislative Budget Committee, which reflects the anticipated current restricted fund revenues for the 2004 fiscal year, and the

1015 budgeted use of such current restricted funds by major object 1016 category. For purposes of this section, the term "current 1017 restricted funds" shall be defined as those public funds available 1018 for financing university operations which are limited by the 1019 donor, or by an agency external to the Board of Trustees of State 1020 Institutions of Higher Learning, to specific purposes, programs, departments or schools, but shall not include endowment funds or 1021 private gifts exempted under the provisions of Section 27-103-5, 1022 Mississippi Code of 1972. 1023

1024 SECTION 69. It is the intention of the Legislature that the 1025 Board of Trustees of State Institutions of Higher Learning 1026 continue to review, and eliminate when possible, duplicating 1027 programs and degrees in the existing institutions of higher 1028 learning in this state.

SECTION 70. It is the intention of the Legislature that the 1029 Board of Trustees of State Institutions shall ensure that no state 1030 1031 appropriations or student tuition and fee receipts, except those 1032 specifically charged for the provision of the services, shall be used to support auxiliary enterprises, with the exception of 1033 1034 intercollegiate athletics at a level designated by the board of trustees. It is the intent of the Legislature that auxiliary 1035 1036 enterprises shall be self-supporting; and that deficits not be taken from funds intended for instruction and academic programs. 1037

SECTION 71. 1038 It is the intention of the Legislature that none 1039 of the funds provided herein to the Board of Trustees of State Institutions of Higher Learning shall be spent to defray tuition 1040 1041 cost or subsidize in any way the direct cost of education, ordinarily paid by the student, of any nonresident alien enrolled 1042 in any state-supported institution of higher learning in the State 1043 of Mississippi. However, this will not apply to any nonresident 1044 1045 alien student if the United States has a reciprocal agreement with 1046 their country on subsidizing the education of a United States

1047 citizen student.

1048 **SECTION 72.** The Board of Trustees of State Institutions of 1049 Higher Learning shall report yearly to the Legislature the 1050 institution compliance with Section 97-11-51, Mississippi Code of 1051 1972, which prohibits deficit spending.

SECTION 73. It is the intention of the Legislature that the Board of Trustees of State Institutions of Higher Learning shall ensure that any funds appropriated pursuant to this act and paid as a fee to or deposited in a financial institution shall be in compliance with Section 109 of the Constitution of the State of Mississippi and Section 25-4-103, Mississippi Code of 1972.

1058 SECTION 74. With the funds herein appropriated to the State 1059 Board of Education, the Mississippi Authority for Educational 1060 Television, and the Mississippi Library Commission, it is the intention of the Legislature that it shall be the agency's 1061 responsibility to make certain that funds required to be 1062 appropriated for "Personal Services" for Fiscal Year 2005 do not 1063 1064 exceed Fiscal Year 2004 funds appropriated for that purpose, 1065 unless programs or positions are added to the agency's Fiscal Year 2005 budget by the Mississippi Legislature. Based on data 1066 1067 provided by the Legislative Budget Office, the State Personnel Board shall determine and publish the projected annual cost to 1068 1069 fully fund all appropriated positions in compliance with the 1070 provisions of this act. It shall be the responsibility of the agency head to insure that no single personnel action increases 1071 1072 this projected cost and/or the Fiscal Year 2004 appropriation for "Personal Services" when annualized. If, at the end of any 1073 1074 calendar month, the State Personnel Board determines that the 1075 agency has taken action(s) which would cause the agency to exceed this projected annual cost or the Fiscal Year 2004 "Personal 1076 Services" appropriated level, when annualized, then only those 1077 actions which reduce the projected annual cost and/or the 1078 1079 appropriation requirement will be processed by the State Personnel

1080 Board until such time as the requirements of this provision are 1081 met.

SECTION 75. It is the intention of the Legislature that none of the funds appropriated by this act shall be expended for increased charges for State Employee and Teacher Health Insurance premium rates assessed by the Department of Finance and Administration in excess of the Fiscal Year 2003 premium rates for the health insurance plan.

1088 **SECTION 76.** It is the intention of the Legislature that no 1089 State General Funds authorized to be expended in this act shall be 1090 used to replace federal funds and/or other special funds which are 1091 being used for salaries authorized under the provisions of this 1092 act and which are withdrawn and no longer available.

SECTION 77. It is the intention of the Legislature that the 1093 State Board of Education, Authority for Educational Television, 1094 Mississippi Library Commission, State Board for Community and 1095 1096 Junior Colleges, and the Board of Trustees of State Institutions 1097 of Higher Learning shall maintain complete accounting and personnel records related to the expenditure of all funds 1098 1099 appropriated under the provisions of this act and that such records shall be in the same format and level of details as 1100 maintained for Fiscal Year 2003. It is further the intention of 1101 the Legislature that the budget requests for Fiscal Year 2005 1102 1103 shall be submitted to the Joint Legislative Budget Committee in a 1104 format and level of detail comparable to the format and level of 1105 detail provided during the Fiscal Year 2004 budget request process. 1106

1107 **SECTION 78.** Of the funds provided herein to the Board of 1108 Trustees of State Institutions of Higher Learning, the following 1109 amount, or so much thereof as may be necessary, shall be expended 1110 to defray the costs of the Center for Advanced Vehicular Studies 1111 at Mississippi State University......\$ 3,500,000.00.

SECTION 79. Of the funds provided herein to the Board of Trustees of State Institutions of Higher Learning, the following amount, or so much thereof as may be necessary, shall be provided to the Mississippi Military Communities Council to assist in consulting efforts associated with Base Realignment and Closure (BRAC)......\$ 200,000.00.

SECTION 80. In addition to all other sums heretofore appropriated, the following sum, or so much thereof as may be necessary, is hereby appropriated out of the Budget Contingency Fund for the purpose of assisting the Mississippi Military Communities Council in consulting efforts for Base Realignment and Closure (BRAC) for the fiscal year ending June 30, 2003...... 83,333.00.

SECTION 81. The money herein appropriated shall be paid by the State Treasurer out of any money in the proper fund or funds as set forth in this act, upon warrants issued by the State Fiscal Officer; and the State Fiscal Officer shall issue his warrants upon requisitions signed by the proper person, officer or officers in the manner provided by law.

1131 **SECTION 82.** This act shall take effect and be in force from 1132 and after July 1, 2003, except that Section 80 shall take effect 1133 and be in force from and after its passage.
