SENATE BILL NO. 3027

AN ACT TO REENACT AND AMEND CHAPTER 879, LOCAL AND PRIVA

- LAWS OF 1992, AS LAST AMENDED BY CHAPTER 905, LOCAL AND PRIVATE 2
- LAWS OF 1999, WHICH CREATES THE GRENADA TOURISM COMMISSION AND AUTHORIZES THE IMPOSITION OF A TOURIST AND CONVENTION TAX; TO 3
- 4
- EXTEND THE REPEAL DATE ON SUCH LAW; AND FOR RELATED PURPOSES. 5
- BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 6
- 7 SECTION 1. Chapter 879, Local and Private Laws of 1992, as
- amended by Chapter 975, Local and Private Laws of 1994, as amended 8
- 9 by Chapter 905, Local and Private Laws of 1999, is reenacted and
- amended as follows: 10
- Section 1. The following words and phrases shall have the 11
- meanings ascribed in this section unless the context clearly 12
- indicates otherwise: 13
- 14 "Bar" means any bar, tavern or lounge where
- alcoholic beverages are sold for consumption on the premises; 15
- "Commission" means the Grenada Tourism Commission; 16
- 17 (C) "City" means the City of Grenada, Mississippi;
- "Governing authorities" means the Mayor and City (d) 18
- Council of the City of Grenada; 19
- "Hotel" or "motel" means a place of lodging with 20
- more than six (6) rental units that at any one (1) time will 21
- 22 accommodate transient guests on a daily or weekly basis and that
- 23 is known to the trade as such;
- "Prepared food" means food prepared on the 24 (f)
- premises; 25
- "Restaurant" means any place, including hotel and 26
- 27 motel dining rooms, cafeterias, cafes and lunch stands, as well as

- 28 grocery and convenience stores where prepared food and drink are
- 29 sold for consumption either upon or off the premises.
- 30 Section 2. (1) There is created and established the Grenada
- 31 Tourism Commission, hereinafter referred to in this act as the
- 32 "commission." The governing authority of the City of Grenada,
- 33 Mississippi, shall be authorized to contract with the Grenada
- 34 Tourism Commission for the administrative responsibilities of a
- 35 tourism program for the Grenada area. All contracts between the
- 36 commission and the City of Grenada, Mississippi, shall be signed
- 37 by the chairman of the commission and shall be on such terms and
- 38 for such duration as the parties may agree. Minutes of all
- 39 meetings shall be kept by the commission and submitted to the
- 40 Grenada City Council.
- 41 (2) The commission shall have jurisdiction and authority
- 42 over all matters relating to establishing, promoting and
- 43 developing tourism, along with related matters in the Grenada
- 44 area. The commission shall be authorized to own, lease, rent or
- 45 otherwise furnish, equip and operate any and all facilities and
- 46 equipment necessary or useful in the promotion of tourism and to
- 47 receive and expend, subject to the provisions of this act,
- 48 revenues from other sources.
- 49 (3) The commission shall be composed of seven (7) members as
- 50 follows:
- 51 (a) One (1) member shall be selected by the Grenada
- 52 Restaurant Association;
- (b) One (1) member shall be selected by the Grenada
- 54 Motel/Hotel Association;
- (c) One (1) member shall be selected by the Grenada
- 56 Hotel/Motel and Restaurant Association;
- 57 (d) The Director of the Grenada County Chamber of
- 58 Commerce or an employee of the Chamber of Commerce appointed by
- 59 the Director of the Chamber;

- (e) One (1) member of the business community at large
- 61 appointed by the Board of Directors of the Chamber of Commerce;
- 62 and
- (f) Two (2) members at large from the city, one (1) of
- 64 which must be minority, appointed by the Grenada City Council.
- Appointments to the commission shall be for a term of two (2)
- 66 years.
- Any vacancy which may occur shall be filled by the appointing
- 68 authority for the unexpired term. Each member shall serve until
- 69 his successor is appointed and qualifies.
- 70 The members shall elect from among themselves a chairman. A
- 71 member of the commission shall not serve as chairman for more than
- 72 two (2) consecutive two-year terms.
- 73 (4) The commission is authorized to employ personnel, to
- 74 obtain supplies, furnishings and other facilities necessary to
- 75 administer the affairs and duties of the commission, and to pay
- 76 for the same out of the revenue provided by this act.
- 77 Section 3. (1) For the purpose of providing funds for the
- 78 commission to promote tourism and conventions, the governing
- 79 authority of the City of Grenada, Mississippi, is authorized to
- 80 levy upon every person, firm or corporation operating a hotel or
- 81 motel in such city, a tax, which may be cited as a "tourism tax,"
- 82 at a rate not to exceed two percent (2%) of the gross proceeds of
- 83 sales from room rentals of hotels and motels in the city,
- 84 including charges for telephone, laundry and other similar
- 85 charges. The tax shall not be levied upon or collected from gross
- 86 proceeds of nontaxable rooms nor room rentals for day meetings
- 87 that do not serve as overnight sleeping accommodations. Such tax
- 88 shall be in addition to all other taxes now imposed.
- 89 (2) The governing authorities also are authorized to impose
- 90 upon persons doing business within the city other than the tax
- 91 imposed on hotel and motel rooms under subsection (1) of this
- 92 section, a tax at a rate of not to exceed one percent (1%) on the

gross receipts of restaurants and bars from retail sales of 93 prepared food, beer and/or alcoholic beverages; however, the tax 94 shall not apply to restaurants/bars whose gross proceeds of sales 95 96 or gross income is less than One Hundred Thousand Dollars 97 (\$100,000.00) per calendar year based upon sales or income for the 98 preceding calendar year. For the purposes of calculating gross proceeds of sales or gross income, the sales or income of all 99 establishments owned, operated or controlled by the same person, 100 101 persons or corporations shall be aggregated.

Before a tax authorized by this act may be imposed, the governing authority of the City of Grenada, Mississippi, shall adopt a resolution declaring its intention to levy the tax and establishing the amount of the tax levy and the date on which this tax initially shall be levied and collected. This date shall be the first day of a month but shall not be sooner than the first day of the second month following the date of adoption of the resolution. Notice of the proposed tax levy shall be published once each week for at least three (3) consecutive weeks in a newspaper having a general circulation in the city. The first publication of such notice shall be made not less than twenty-one (21) days prior to the date fixed in the resolution on which the governing authority proposes to levy such tax, and the last publication of such notice shall be made not more than seven (7) days prior to such date. If, within the time of giving notice, twenty percent (20%) or fifteen hundred (1500), whichever is less, of the qualified electors of the city file a written petition against the levy of such tax, then such tax shall not be levied unless authorized by a majority of the qualified electors of such city voting at an election called and held for that purpose. Prior to the effective date of the tax levy approved as herein provided, the governing authority shall furnish to the Chairman of the State Tax Commission a certified copy of the resolution

evidencing such tax levy.

- 126 (4) Persons, firms or corporations liable for the tax

 127 imposed herein shall add the amount of tax to the sales price of

 128 room rentals and, in addition thereto, shall collect, insofar as

 129 practicable, the amount of the tax due from the person receiving

 130 the services at the time of payment therefor.
- (5) Such tax shall be collected by and paid to the State Tax Commission on a form prescribed by the State Tax Commission, in the same manner that state sales taxes are computed, collected and paid; and the full enforcement provisions and all other provisions of Chapter 65, Title 27, Mississippi Code of 1972, shall apply as necessary to the implementation and administration of this act.
 - (6) The proceeds of such tax, less three percent (3%) to be retained by the State Tax Commission to defray the costs of collection, shall be paid to the governing authority of the City of Grenada, Mississippi, on or before the fifteenth day of the month following the month in which collected.
 - (7) The proceeds of the tax shall not be considered by the city as general fund revenues but shall be dedicated to and used by the commission solely for the purpose of carrying out programs and activities designed to attract tourists to the city and surrounding area. Fifty percent (50%) of the tax or revenue shall be placed in an interest bearing tourism escrow fund for the construction, financing and operation of a convention center or any other use that may promote tourism as determined by the City of Grenada. The convention center shall be carefully planned and constructed with the cooperation of the governing authorities and the commission.
- 153 (8) Before the expenditure of funds herein prescribed, a
 154 budget reflecting the anticipated receipts and expenditures shall
 155 be approved by the governing authorities. The first budget of
 156 receipts and expenditures shall cover the period beginning with
 157 the effective date of the taxes and ending with the end of the

158	city's	fisca	ıl year	, and,	thereaf	ter,	the	budget	shall	be	on	the
159	same f	iscal	basis	as the	budget	of th	ne c	ity.				

- Section 4. The books of the commission shall be audited 160 annually by an independent certified public accountant, and the 161 162 accountant shall make a written report of his audit to the commission who shall thereupon submit a copy of such report to the 163 164 governing authority of the City of Grenada, Mississippi. Such audit shall be made and completed as soon as practicable after the 165 close of the fiscal year, and copies of the report of such audit 166 shall be filed with the city clerk within fifteen (15) days after 167 receipt thereof by the commission. 168
- Section 5. Sections 1 through 4 of <u>this act</u> shall stand repealed on September 30, 2008.
- 171 **SECTION 2.** This act shall take effect and be in force from 172 and after its passage.
