SENATE CONCURRENT RESOLUTION NO. 554

1 A CONCURRENT RESOLUTION COMMENDING AND CONGRATULATING MR.
2 SAMUEL WEBB SCALES, CIVILIAN AIDE TO THE SECRETARY OF THE ARMY FOR
3 THE STATE OF MISSISSIPPI, UPON THE OCCASION OF HIS RETIREMENT FROM
4 THIS POSITION AND FOR HIS EXEMPLARY MILITARY SERVICE.

5 WHEREAS, appointed in April of 1990, Mr. Samuel Webb Scales
6 retired in September 2002, as Civilian Aide to the Secretary of
7 the Army for the State of Mississippi; and

8 WHEREAS, civilian aides advise the Secretary of the Army, the
9 Army Chief of Staff and the Continental U.S. Army Commander in the
10 area of military jurisdiction where the aide lives; and

11 WHEREAS, civilian aides are appointed by the Secretary of the
12 Army on the basis of demonstrated patriotism, their interest in
13 the Army, business and professional leadership, and the ability to
14 increase public understanding of the Army; and

15 WHEREAS, Mr. Scales served in the U.S. Marine Corps from
16 1941-1945 and attained the rank of Sergeant Major. He served in
17 the U.S. Army Reserve from 1948-1972 and retired as a Lieutenant
18 Colonel. During that time he served in various assignments to
19 include: Troop Commander, Calvary; Aide de Camp, CG, Armored
20 Division; Battalion Commanding Officer, Armor; General Staff
21 Officer, Joint General Staff, Thailand; General Staff Officer,
22 Australian Army; and

23 WHEREAS, Mr. Scales is a native of Starkville, Mississippi,
24 and his impressive resume includes the following: Chairman of the
25 Board of American Bristol Insurance Company; a graduate of
26 Starkville High School; the University of the South, Sewanee,
27 Tennessee; Mississippi State University; Vanderbilt Law School;
28 Vice President of First National Bank, Harlingen, Texas; Chairman



29 of the Board, Starr Associates, Bangkok, Thailand; Liaison
30 Officer, Phoenix Assurance, Sydney, Australia; Chairman of the
31 Board, Servicios Y Comisiones Continental S.A. de C.V., Mexico
32 City; Senior Vice President of Continental Insurance Company and
33 Regional Manager for Latin American, Panama, R.P.; CEO or Director
34 of companies in the following countries: Mexico, Guatemala,
35 Panama, Venezuela, Columbia, Chile, Brazil, Argentina and the
36 Dominican Republic; and Corporate Officer of 14 U.S. Corporations;

38 WHEREAS, Mr. Scales is a member of the Association of the
39 U.S. Army (AUSA); Navy League; Sigma Chi Fraternity; and the
40 Episcopal Church. Mr. Scales and his wife, Bette, live in
41 Starkville, Mississippi, and they have three children; and

42 WHEREAS, it is with great pride that we recognize the
43 accomplishments of this Mississippian who has brought honor to his
44 community, his state and to his country:

45 NOW, THEREFORE, BE IT RESOLVED BY THE SENATE OF THE STATE OF
46 MISSISSIPPI, THE HOUSE OF REPRESENTATIVES CONCURRING THEREIN, That
47 we do hereby congratulate Lt. Colonel Samuel Webb Scales, Civilian
48 Aide to the Secretary of the Army for the State of Mississippi,
49 upon the occasion of his retirement from this esteemed position
50 and commend him for his exemplary military service record.
