SENATE CONCURRENT RESOLUTION NO. 621

1 A CONCURRENT RESOLUTION SUSPENDING THE DEADLINES FOR THE  
2 PURPOSE OF REQUESTING THE DRAFTING, AND THE INTRODUCTION,  
3 CONSIDERATION AND PASSAGE, OF A BILL ENTITLED "AN ACT TO AMEND  
4 SECTION 27-5-101, MISSISSIPPI CODE OF 1972, TO REVISE THE DATE  
5 UPON WHICH A PORTION OF THE REVENUES DERIVED FROM MOTOR FUEL TAXES  
6 IS REQUIRED TO BE DEPOSITED INTO THE GAMING COUNTIES BOND SINKING  
7 FUND FOR THE PURPOSES OF PAYING THE DEBT SERVICE ON BONDS ISSUED  
8 IN SUPPORT OF THE GAMING COUNTIES INFRASTRUCTURE PROGRAM; TO  
9 PROVIDE FOR THE TRANSFER OF A PORTION OF THE FUNDS DEPOSITED INTO  
10 THE GAMING COUNTIES BOND SINKING FUND INTO THE STATE HIGHWAY FUND;  
11 AND FOR RELATED PURPOSES."

12 BE IT RESOLVED BY THE SENATE OF THE STATE OF MISSISSIPPI, THE  
13 HOUSE OF REPRESENTATIVES CONCURRING THEREIN, That the Joint Rules  
14 of the Senate and the House are hereby suspended for the purpose  
15 of requesting the drafting, introduction, consideration and  
16 passage, regardless of any deadlines imposed by said rules, of a  
17 bill entitled "AN ACT TO AMEND SECTION 27-5-101, MISSISSIPPI CODE  
18 OF 1972, TO REVISE THE DATE UPON WHICH A PORTION OF THE REVENUES  
19 DERIVED FROM MOTOR FUEL TAXES IS REQUIRED TO BE DEPOSITED INTO THE  
20 GAMING COUNTIES BOND SINKING FUND FOR THE PURPOSES OF PAYING THE  
21 DEBT SERVICE ON BONDS ISSUED IN SUPPORT OF THE GAMING COUNTIES  
22 INFRASTRUCTURE PROGRAM; TO PROVIDE FOR THE TRANSFER OF A PORTION  
23 OF THE FUNDS DEPOSITED INTO THE GAMING COUNTIES BOND SINKING FUND  
24 INTO THE STATE HIGHWAY FUND; AND FOR RELATED PURPOSES."
