SENATE RESOLUTION NO. 113

1 A RESOLUTION COMMENDING SENATOR BARBARA M. BLACKMON FOR HER  
2 OUTSTANDING LEGISLATIVE RECORD AND DEDICATED SERVICE TO THE PEOPLE  
3 OF THE STATE OF MISSISSIPPI.

4 WHEREAS, State Senator Barbara Martin Blackmon, a Democrat  
5 from Canton, Mississippi, is completing 12 years representing  
6 District 21, which includes parts of Humphreys, Madison and Yazoo  
7 Counties; and

8 WHEREAS, Senator Blackmon has indicated that she will not run  
9 for reelection at the expiration of her present term in order to  
10 seek other elective office; and

11 WHEREAS, in Barbara Blackmon, the residents of District 21  
12 have lost an honest, dependable State Senator with unquestioned  
13 integrity; and

14 WHEREAS, Senator Blackmon is Vice Chairman of the Insurance  
15 Committee, and has served with distinction on the Appropriations,  
16 Finance, Constitution, Highways and Transportation, Judiciary, and  
17 Public Health and Welfare Committees, this committee experience  
18 representing substantial legislative influence; and

19 WHEREAS, Senator Blackmon was a champion for issues relating  
20 to the protection of women and domestic rights issues, and  
21 introduced legislation to reconcile state law to Mississippi  
22 Supreme Court decisions affecting the equitable distribution of  
23 assets in divorce cases, which received accolades from the Family  
24 Law Section of the Mississippi Bar Association; and

25 WHEREAS, Barbara was born on December 7, 1955, in Jackson,  
26 Mississippi, attended Wingfield High School, received a bachelor's



27 Degree from Jackson State University, an M.B.A. from the  
28 University of Alabama, attended the University of Santa Clara  
29 School of Law, and earned her Juris Doctorate at the University of  
30 Mississippi School of Law and a Masters of Laws in Taxation from  
31 the New York University School of Law; she is an Attorney and  
32 member of The Mississippi Bar and the New York Bar; she is active  
33 in the Baptist Church, belongs to the JSU Development Foundation,  
34 the United Way of the Capital Area, Stewpot of Canton, the  
35 American Red Cross, and the Foundation for Education and Economic  
36 Development; and she is dedicated to her husband, Representative  
37 Ed Blackmon, and children, Madison, Edward and Bradford Jerome;
