**AMENDMENT No. 1 PROPOSED TO**

**Senate Bill NO. 2636**

**By Representative(s) Scott(17), Young**

1           **AMEND** by deleting lines 30 and 31 in their entirety and  
2 inserting in lieu thereof the following:

3           "SECTION 1. (1) Prior to October 1, 2003, the Oversight  
4 Committee established in Section 5 of this act shall cause to be  
5 conducted an assessment of all prekindergarten"

6           **AMEND FURTHER** on line 59 by deleting the word "September" and  
7 inserting the word "October".

8           **AMEND FURTHER** on line 99 by deleting the figure "1", and  
9 inserting in lieu thereof the figures "15".

10           **AMEND FURTHER** after line 115 by inserting the following new  
11 section 5 and renumbering the succeeding section, the new section  
12 5 to read as follows:

13           SECTION 5. There shall be established an Oversight  
14 Committee, which shall oversee the process and conducting of  
15 assessments in order to carry out the mandates of this act. The  
16 committee shall consist of the following members:

17                   (a) The current members of the Interagency Advisory  
18 Committee for Early Childhood Services;

19                   (b) One (1) member from a parochial child care center,  
20 to be appointed by the Speaker of the House;

21                   (c) The Chairman or Vice-Chairman of the Senate  
22 Education Committee;

23                   (d) The Chairman or Vice-Chairman of the House Education

24 Committee;

25 (e) The Chairman or Vice-Chairman of the Senate  
26 Universities and Colleges Committee;

27 (f) The Chairman or Vice-Chairman of the House  
28 Universities and Colleges Committee.

29 **AMEND FURTHER** the title by deleting line 3 in its entirety  
30 and inserting in lieu thereof the following: "OVERSIGHT COMMITTEE  
31 ESTABLISHED BY THIS ACT TO CAUSE TO BE CONDUCTED AN ASSESSMENT OF  
32 ALL"

33 **AMEND FURTHER** the title on line 6 by deleting the words  
34 "STATE BOARD OF EDUCATION" and inserting in lieu thereof the words  
35 "OVERSIGHT COMMITTEE".

36 **AMEND FURTHER** the title on line 10 by deleting the words  
37 "THE STATE BOARD OF EDUCATION" and inserting in lieu thereof the  
38 words "CERTAIN AGENCIES".

39 **AMEND FURTHER** the title on line 28 by inserting the following  
40 language after the semicolon: "TO CREATE AN OVERSIGHT COMMITTEE  
41 OVERSEE THE PROCESS AND CONDUCTING OF ASSESSMENTS UNDER THIS ACT;"
