Amend by striking all after the enacting clause and inserting in lieu thereof the following:

 44 under this section shall be expended after July 31, 2002, unless
 45 based upon a competitive bid process to provide medical care and
 46 pharmaceuticals to state inmates through a contractual arrangement
 47 with not less than a ten percent (10%) savings below the
 48 Department of Corrections Fiscal Year 2002 costs for providing
 49 health care to state inmates. Not later than June 15, 2002, the
 50 Department of Corrections shall inform the Chairmen of the House
 51 Penitentiary Committee, the Senate Corrections Committee, and two
 52 members from the Appropriations Committees of the House of
 53 Representatives and Senate to be selected by the Chairmen of the
 54 Appropriations Committees of each respective house of the feasible
 55 options to provide health care to state inmates.

118 Funds are provided herein to adjust the Variable Compensation
 119 Plan to ensure that all full-time employees receive a pay increase
 120 equal to fifty percent (50%) of the realignment component of the
 121 Variable Compensation Plan or Six Hundred Dollars (\$600.00),
 122 whichever is greater, beginning on January 1, 2003.

123 With the funds herein appropriated, it is the intention of
 124 the Legislature that it shall be the agency's responsibility to
 125 make certain that funds required to be appropriated for "Personal
 126 Services" for Fiscal Year 2004 do not exceed Fiscal Year 2003
 127 funds appropriated for that purpose, unless programs, positions or
 128 pay increases are added to the agency's budget by the Mississippi
 129 Legislature. Based on data provided by the Legislative Budget
 130 Office, the State Personnel Board shall, on July 1, 2002, publish

131 separate annual projection reports, based on July 1, 2002, data,
132 for the period of July 1, 2002, through December 31, 2002, and
133 January 1, 2003, through June 30, 2003, that project the annual
134 cost to fully fund all appropriated positions in compliance with
135 the provisions of this act. It shall be the responsibility of the
136 agency head to ensure that no single personnel action increases
137 this projected cost and/or the Fiscal Year 2003 appropriation for
138 "Personal Services," as annualized on a semiannual basis in
139 accordance with the provisions of this act. If, at the end of any
140 calendar month, the State Personnel Board determines that the
141 agency has taken action(s) which would cause the agency to exceed
142 this projected annual cost or the Fiscal Year 2003 "Personal
143 Services" appropriated level, when annualized in compliance with
144 the provisions of this act, then only those actions which reduce
145 the projected annual cost and/or the appropriation requirement
146 will be processed by the State Personnel Board until such time as
147 the requirements of this provision are met.

148 Any transfers or escalations shall be made in accordance with
149 the terms, conditions and procedures established by law, except
150 that no transfers shall be made which reduce funds allocated in
151 Section 3 to Regional Facilities or Private Prisons.

152 No general funds authorized to be expended herein shall be
153 used to replace federal funds and/or other special funds which are
154 being used for salaries authorized under the provisions of this
155 act and which are withdrawn and no longer available.

156 **SECTION 2.** This act shall take effect and be in force from
157 and after its passage.

inserting in lieu thereof the following:**
