1	AMEND by inserting the following after line 839 and renumber
2	subsequent section(s) accordingly:
3	<b>SECTION *.</b> In recognition of the patriotic service rendered
4	by Mississippians who are honorably discharged veterans who served
5	in the United States Armed Forces during the Vietnam Conflict and
6	were awarded a Vietnam Service Ribbon, any such person is
7	privileged to obtain distinctive motor vehicle license plates or
8	tags for each motor vehicle registered in his name identifying his
9	status as a Vietnam veteran. The State Tax Commission, with
10	concurrence by the State Veterans Affairs Board, shall develop
11	decals to be affixed to the license tag indicating branch and
12	period of military service. The distinctive plates or tags shall
13	be of a color and design designated by the Tax Commission with
14	concurrence by the State Veterans Affairs Board.
15	The distinctive license plates shall be prepared by the Tax
16	Commission and shall be issued through the tax collectors of the
17	counties in the same manner as are other motor vehicle license
18	plates or tags. An additional annual tag fee of Thirty Dollars
19	(\$30.00) shall be collected by the tax collector for such license
20	plates or tags and shall be remitted to the Tax Commission on a
21	monthly basis as prescribed by the commission. The additional fee
22	is due and payable at the time the original application is made
23	for a distinctive tag under this section and thereafter annually

- 24 at the time of renewal registration as long as the owner retains
- 25 the distinctive license tag. The State Tax Commission shall
- 26 deposit such fee to the credit of a fund to be administered by the
- 27 board overseeing the veterans nursing homes in this state for the
- 28 benefit of indigent veterans who are residents of such nursing
- 29 homes.
- 30 An applicant for such distinctive plates shall present to the
- 31 issuing official written evidence of the veteran's service. Such
- 32 evidence shall include a copy of the applicant's DD-214 form, a
- 33 Report of Separation from Military Service, a military discharge
- 34 document, or a written certification of military service from the
- 35 State Veterans Affairs Board. The distinctive license plates or
- 36 tags so issued shall be used only upon a personally or jointly
- 37 owned private passenger vehicle (to include station wagons,
- 38 recreational motor vehicles and pickup trucks) registered in the
- 39 name, or jointly in the name, of the person making application
- 40 therefor, and when issued to such person shall be used upon the
- 41 vehicle for which issued in lieu of the standard license plate or
- 42 license tag normally issued for such vehicle.
- The distinctive license plates shall not be transferable
- 44 between motor vehicle owners; and in the event the owner of a
- 45 vehicle bearing a distinctive plate shall sell, trade, exchange or
- 46 otherwise dispose of the vehicle, such plate shall be retained by
- 47 such owner and returned to the tax collector.
- FURTHER, AMEND line 39 of the title by inserting the
- 49 following after the semicolon:
- 50 TO AUTHORIZE THE ISSUANCE OF DISTINCTIVE MOTOR VEHICLE LICENSE
- 51 PLATES FOR MISSISSIPPIANS WHO ARE HONORABLY DISCHARGED VETERANS
- 52 WHO SERVED IN THE UNITED STATES ARMED FORCES DURING THE VIETNAM
- 53 CONFLICT AND WERE AWARDED A VIETNAM SERVICE RIBBON;
