## HOUSE BILL NO. 28

1 AN ACT TO AMEND SECTION 75-55-22, MISSISSIPPI CODE OF 1972,  
2 TO PROHIBIT THE USE OF METHYL TERT-BUTYL ETHER (MTBE) AS A FUEL  
3 ADDITIVE; TO REVISE LABELING REQUIREMENTS FOR CERTAIN GASOLINE;  
4 AND FOR RELATED PURPOSES.

5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:

6 **SECTION 1.** Section 75-55-22, Mississippi Code of 1972, is  
7 amended as follows:

8 75-55-22. Any person located in Mississippi, except the  
9 holder of a refiner or a processor's permit, who blends or mixes  
10 alcohol blended fuel for sale, delivery, exchange or use in  
11 Mississippi shall obtain from the commissioner a permit  
12 authorizing him to engage in business as a producer of alcohol  
13 blended fuel. Each producer of alcohol blended fuel shall have  
14 the necessary equipment to insure a complete and homogeneous  
15 mixture. The finished product shall meet all of the state's  
16 standards and specifications and shall not be transferred, sold,  
17 exchanged, delivered, used or disposed of by any other means until  
18 approved by the commissioner and the State Chemist. Any use of  
19 Methyl Tert-Butyl Ether (MTBE) as a fuel additive is prohibited.

20 All alcohol blended fuel transported or imported into the  
21 State of Mississippi shall comply with all specifications and  
22 standards adopted by this state for such use.

23 All gasoline, leaded or unleaded, kept, offered, or exposed  
24 for sale, or sold, at retail containing eleven percent (11%) or  
25 more by volume of ethanol, methanol or an ethanol/methanol  
26 mixture, shall be identified as "with" or "containing" (or similar  
27 wording) "ethanol," "methanol" or "ethanol/methanol" on the upper  
28 fifty percent (50%) of the dispenser front panels in a position

29 clear and conspicuous from the driver's position, in a type at  
30 least one-half (1/2) inch in height, and one-sixteenth (1/16) inch  
31 stroke (width of type). All letters shall be black with a  
32 contrasting background.

33 All distributors, processors, refiners, and any other persons  
34 receiving, storing, selling, distributing or transporting gasoline  
35 that contains eleven percent (11%) by volume or more of methanol,  
36 ethanol or other alcohol shall identify the type or chemical name  
37 and percentage of such alcohol on any invoice, bill of lading,  
38 shipping paper or on any other type of documentation which is used  
39 in normal and customary practice in the petroleum industry.

40 **SECTION 2.** This act shall take effect and be in force from  
41 and after July 1, 2004.
