HOUSE BILL NO. 59

AN ACT TO REQUIRE THE LICENSING OF COMMERCIAL FIRE 1 SUPPRESSION SYSTEMS FOR COOKING OPERATIONS AND PORTABLE FIRE 2 EXTINGUISHERS; TO PROVIDE FOR THE ADMINISTRATION OF SUCH LICENSING BY THE STATE FIRE MARSHAL; TO ESTABLISH A PENALTY FOR VIOLATING 3 4 THE LICENSING PROVISIONS OF THIS ACT; AND FOR RELATED PURPOSES. 5 6 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI: 7 SECTION 1. In the interest of public safety, any person, 8 company or corporation who engages in the sale, installation or 9 service of commercial fire suppression systems for cooking operations and portable fire extinguishers shall comply with all 10 appropriate standards of the National Fire Protection Association 11 and the requirements of the International Fire Code as published 12 13 by the International Code Council in corporation with the Southern 14 Building Code Congress International, Inc., Birmingham, Alabama, as revised or amended. 15

16 <u>SECTION 2.</u> The State Fire Marshal shall promulgate such 17 rules and regulations as are necessary to carry out the provisions 18 and licensure requirements for all persons, company or 19 corporations for commercial fire suppression systems for cooking 20 operations and portable fire extinguishers.

21 SECTION 3. (1) After July 1, 2004, every person, company or 22 corporation who engages in the sale, installation and service of 23 commercial fire suppression systems for cooking operations and portable fire extinguishers within the State of Mississippi shall 24 apply for and obtain a license from the State Fire Marshal. All 25 funds received by the State Fire Marshal shall be deposited in a 26 27 special fund account in the State Treasury to be credited to the 28 Department of Insurance.

(2) The applicant shall certify in the application to the State Fire Marshal that the applicant is able to comply with all requirements of the National Fire Protection Association Standards as they relate to the installation, service and maintenance of commercial fire suppression systems for cooking operations and portable fire extinguishers.

35 (3) License shall be issued to persons, companies or 36 corporations who have satisfactorily met the minimum experience 37 requirements and completed and passed a competency test 38 administered by the State Fire Marshal.

39 (4) The State Fire Marshal shall administer this act and may 40 set or charge the amount of the license fee as may be necessary 41 for the administration and enforcement of this act. Such fee 42 shall not exceed One Hundred Dollars (\$100.00).

SECTION 4. The State Fire Marshal may issue and deliver an 43 order to cease and desist to any persons, companies or 44 45 corporations who he has reason to believe is or has been in 46 violation of this act. Whoever fails to comply with any order issued under this section shall be assessed a civil fine of not 47 48 more than One Thousand Dollars (\$1,000.00) for each day of such violation. Violation of this act or failure to comply with an 49 50 order to cease and desist shall also constitute cause for revocation of the license. 51

52 Any persons, companies or corporations that knowingly and 53 willfully fail to obtain the applicable license under this act and who are required to obtain such license under this act and who may 54 55 knowingly and willfully violate any provision of this act or any rules and regulations made hereafter with respect to the 56 57 commercial fire suppression systems for cooking operations and portable fire extinguishers are guilty of a misdemeanor and, upon 58 59 conviction thereof, shall be fined not more than One Thousand 60 Dollars (\$1,000.00) or imprisoned not more than one (1) year, or

61 both.
