- 5 BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MISSISSIPPI:
- 6 **SECTION 1.** (1) There is created the Public/Mass Transit
- 7 Task Force to study and make recommendations with regard to
- 8 present and future needs of public transportation in Mississippi.
- 9 The task force shall make a report of its findings and
- 10 recommendations to the Legislature during the 2005 Regular
- 11 Legislative Session, including any recommended legislation.
- 12 (2) The task force shall be composed of the following nine
- 13 (9) members:
- 14 (a) The Chairman of the House Transportation Committee;
- 15 (b) The Chairman of the Senate Highways and
- 16 Transportation Committee;
- 17 (c) Two (2) members of the Mississippi Public
- 18 Transportation Association appointed by the association's
- 19 executive director;
- 20 (d) The Executive Director of the Mississippi
- 21 Department of Transportation;
- 22 (e) The Director of Public Transit of the Mississippi
- 23 Department of Transportation; and
- 24 (f) Three (3) persons appointed by the Governor, each
- 25 of whom represents either metropolitan planning organizations or
- 26 planning and development districts.
- 27 (3) Appointments shall be made within thirty (30) days after
- 28 the effective date of this act, and, within fifteen (15) days

- 29 thereafter on a day to be designated jointly by the Speaker of the
- 30 House and the Lieutenant Governor, the task force shall meet and
- 31 organize by selecting from its membership a chairman and a vice
- 32 chairman. The vice chairman shall also serve as secretary and
- 33 shall be responsible for keeping all records of the task force. A
- 34 majority of the members of the task force shall constitute a
- 35 quorum. In the selection of its officers and the adoption of
- 36 rules, resolutions and reports, an affirmative vote of a majority
- 37 of the task force shall be required. All members shall be
- 38 notified in writing of all meetings, such notices to be mailed at
- 39 least fifteen (15) days before the date on which a meeting is to
- 40 be held.
- 41 (4) Members of the task force who are not legislators, state
- 42 officials or state employees shall be compensated at the per diem
- 43 rate authorized by Section 25-3-69 and shall be reimbursed in
- 44 accordance with Section 25-3-41 for mileage and actual expenses
- 45 incurred in the performance of their duties. Legislative members
- 46 of the task force shall be paid from the contingent expense funds
- $\,$ 47 $\,$ of their respective houses in the same manner as provided for
- 48 committee meetings when the Legislature is not in session.
- 49 However, no per diem or expense for attending meetings of the task
- 50 force will be paid to legislative members of the task force while
- 51 the Legislature is in session. No task force member may incur per
- 52 diem, travel or other expenses unless previously authorized by
- 53 vote, at a meeting of the task force, which action shall be
- 54 recorded in the official minutes of the meeting. Nonlegislative
- 55 members shall be paid from any funds made available to the task
- 56 force for that purpose.
- 57 (5) The task force shall use clerical and legal staff
- 58 already employed by the Legislature and any other staff assistance
- 59 made available to it. To effectuate the purposes of this section,
- 60 any department, division, board, bureau, commission or agency of
- 61 the state or of any political subdivision thereof shall, at the

- 62 request of the chairman of the task force, provide to the task
- 63 force such facilities, assistance and data as will enable the task
- 64 force properly to carry out its duties.
- 65 **SECTION 2.** This act shall take effect and be in force from
- 66 and after July 1, 2004.
