6	SECTION 1. Section 99-15-26, Mississippi Code of 1972, is
7	amended as follows:
8	99-15-26. (1) In all criminal cases, felony and
9	misdemeanor, other than crimes against the person, the circuit or
LO	county court shall be empowered, upon the entry of a plea of
L1	guilty by a criminal defendant, to withhold acceptance of the plea
L2	and sentence thereon pending successful completion of such
L3	conditions as may be imposed by the court pursuant to subsection
L4	(2) of this section. In all misdemeanor criminal cases, other
L5	than crimes against the person, the justice or municipal court
L6	shall be empowered, upon the entry of a plea of guilty by a
L7	criminal defendant, to withhold acceptance of the plea and
L8	sentence thereon pending successful completion of such conditions
L9	as may be imposed by the court pursuant to subsection (2) of this
20	section. No person having previously qualified under the
21	provisions of this section or having ever been convicted of a
